COUNTRY PROGRAMMES AND MID-TERM REVIEWS

Mid-term review scheduling

Report of the Administrator

I. PURPOSE AND BACKGROUND

1. The present report responds to Governing Council decision 92/28 of 26 May 1992, in which the Council requested the Administrator to report on mid-term reviews of country and intercountry programmes carried out during the fifth cycle, 1992-1996.

2. In paragraph 5 of its decision 93/4 of 19 February 1993, the Governing Council took note of the tentative timetable for mid-term reviews 1993-1995 as contained in document DP/1993/6; in that document, the Administrator proposed to report to the Council on mid-term reviews on a biannual basis. Reviews conducted in the first half of the year were to be reported on to the Council at a special session in the following year, while those held in the latter half would be reported on at the regular sessions.

II. MID-TERM REVIEWS, 1993-1995

3. UNDP conducted three mid-term reviews of the country programmes for India, Indonesia and Zambia in the first half of 1993. In accordance with the above arrangement, they are reported on in an overview (DP/1994/6) and in separate reports for each country, Zambia (DP/1994/6/Add.1), India (DP/1994/6/Add.2) and Indonesia (DP/1994/6/Add.3).

4. In the second half of 1993, four mid-term review exercises were undertaken for the country programmes of Cape Verde, China, Fiji and Tonga. Summaries of the mid-term review reports for Cape Verde (DP/1994/41/Add.1) and

China (DP/1994/41/Add.2) have been distributed to members of the Board, while the reports for Fiji and Tonga are available upon request. The findings from these reviews will be reflected in the overview of a larger number of reviews undertaken in the first half of 1994.

5. It is anticipated that the format and periodicity of reporting proposed by the Administrator in his report on the tentative timetable for mid-term reviews 1993-1995 (DP/1993/6), will be retained by the Executive Board. Accordingly, a revised schedule of the various mid-term reviews as at 30 April 1994 is presented in the annex. It is planned that at least 25 country and intercountry mid-term reviews will be undertaken in the first half of 1994 and reported on to the Board at its first regular session in 1995. The mid-term reviews for the latter half of 1994 would be reported on to the Board during the latter part of 1995.

III. EXECUTIVE BOARD ACTION

6. The Executive Board may wish to:

Confirm the arrangement for the submission of mid-term reviews as contained in document DP/1993/6.
