



BUILDING THE POST-2015 DEVELOPMENT AGENDA:

open and inclusive global consultations

This initiative represents an unprecedented effort to carry out a **global conversation** on the future people want for themselves. **For the first time in history**, people from all over the world had the opportunity to express their priorities and take them to member states on a global scale, to influence the intergovernmental negotiations on the post-2015 development agenda.

Consultations were conducted at the national, regional and global level to **inform the discussions** around the post-2015 agenda with the perspectives of people from all parts of the world, including poor and vulnerable groups. The **outcomes and recommendations** coming forth from these consultations fed into discourses at the global level, including the High Level Panel on post-2015.

The national consultations were led by United Nations country teams and directed towards the **widest possible audience**, including government actors, civil society, and groups most concerned with the post-2015 development agenda, such as vulnerable and marginalized communities. **Women were a key target**, due to their role in development policies and in consideration of the importance of gender in the future development agenda. The private sector and civil society also brought an important contribution to the post-2015 development debate.

The findings of this global conversation contain important messages for governments as they seek to agree on a new development agenda.

- People demand to play a role in shaping and changing their world.
- The fundamental areas covered by the MDGs remain critically important. At the same time, there is a call to strengthen ambition and urgency.
- People are indignant at the injustice they feel because of growing inequalities and insecurities that exist particularly for poorer and marginalized people.
- The challenges are complex and interlinked, requiring a sustainable development agenda that is integrated, holistic and universal, applying to all countries and all people.
- People call for a new agenda built on human rights, and universal values of equality, justice and security. Better governance underpins many of their calls.
- The focus on concrete, measurable goals should be retained but measurement of progress needs to be improved. A data revolution will support an accountability revolution.

The ROK-UNDP MDG Trust Fund has contributed \$17.85 million towards nine country projects and two global projects that seek to improve livelihoods of the poor and vulnerable.



Objectives:

Building and leading a strategic coalition of partners to shape the post-2015 development agenda through global broad mobilization and engagement of government, grassroots, academics, civil society organizations, and other stakeholders.

Our results:

Inclusive national consultations in 87 countries from all regions, supported by regional consultations led by UN regional Commissions, to stimulate the debate on the post 2015 development agenda.

Thematic consultations on 11 themes: education, governance, conflict and fragility, food security, health, inequalities, growth and employment, population dynamics, environmental sustainability, water and energy.

Global and regional consultations with academia, media, private sector, private foundations, employers and trade unions, civil society, and decision-makers on the current central challenges to the post-2015 development agenda and to a broad coalition of change.

Knowledge products on the post-2015 development agenda and outcomes of the consultations, including the High-Level Panel's Report on the Post-2015 Agenda.

ICT tools leveraged to facilitate an open interaction and information exchange among a range of stakeholders about post-2015.
