### **Eligibility criteria**

- Be a farmer
- Own a farm (for personal or family use)
- The farm must not belong to a cooperative or any other form of grouping;
- All or part of the farm must have been degraded, vandalised or abandoned as a result of the security crisis.
- The farm must be located in an administrative district of the South-West and North-West Regions.
- The farm must be located in the same area as the farmer's dwelling house.
- The farm must not have been fully rehabilitated by the farmer.

### **Composition of the file**

- An identification sheet including personal, administrative and technical information required. Subject to rejection, this sheet must be signed by the applicant and endorsed by the village/quarter head (or any other person acting in his place) and 2 (two) members of the community.
- Photocopy of the farmer's national identity card
- Two 4 x 4 photos of the applicant
- Pictures of the farm before and after degradation, if any

**Where and how to submit files:** Council office where the farm is located. Farmers' files must be deposited at the council office against receipt by the village or quarter heads or any other person acting in their place **(Households have to submit their files to Chiefs/Quarter heads).**
