- Be a proprietor or school representative/regional delegate of MINEDUB/MINESEC

- Educational establishment was operational as per ministry guide
- The rehabilitation should not be included in the 2020 public investment budget

**Composition of the file****For private schools**

- An identification sheet containing information about the educational establishment and the promoter/representative. Subject to rejection, the identification sheet must be signed by the applying body and endorsed by the divisional delegate of the administration concerned (MINEDUB, MINESEC)
- An authorization of creation from the ministry concerned
- Photocopy of the national identity card of the representative
- 2 (two) 4 x 4 size photographs of the applicant (for the individuals)
- Pictures of the school before and after the damage
- Any other document to show will be of added advantage

**Public schools are exempt from this procedure.**

**Where and how to submit files:** SDO's office where the school is located by the applicants

**P.S: If erroneous, falsified or unsubstantiated information is discovered during the data cross-checking phase, the culprits will not receive this support.**
