



Through **eJarima** portal (<https://dyhxx.ejarima.uz>) citizens and organizations can send DVR records of traffic violations to the State Traffic Safety Service (STSS) and receive a reward of

5% of the minimal salary



(11 150 UZS / 1.17 USD) once the violation is approved by the STSS.

WHY DO WE NEED THIS?

To improve driving culture and abidance by traffic regulations, to reduce traffic violations and accidents

To decrease administrative and infrastructural burden on the municipality, to reduce traffic

To collect additional contributions to the budget

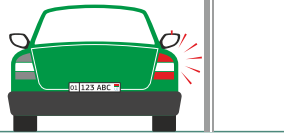
To engage the public in addressing the issue of road safety



SYSTEM EFFICIENCY



50 000+ traffic violations reported in July-December 2019



To compare, in 2018 **109 280** traffic violations were recorded in total

6 700 registered users



The amount of payments to the budget from penalties amounted to more than **19** billion soums



The amount of remuneration to active citizens amounted to more than **381** million soums

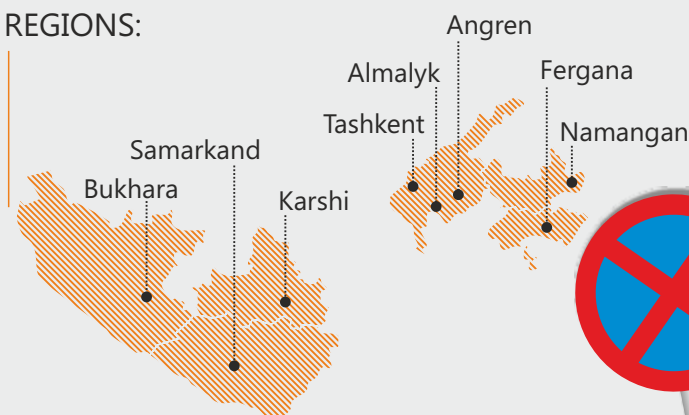

WHAT KIND OF VIDEO YOU CAN SEND THROUGH ejarima

The video recordings are accepted with a duration of no more than



The resolution of the video must be at least **720x480 PIXELS**



The video recordings are accepted only if made using the **DVRs**

The video must show the **DATE AND TIME** when the recording was made

The video must display the **MODEL AND BRAND OF THE VEHICLE** recorded, **THE LICENSE PLATE NUMBER** must be visible and distinguishable

The videos are accepted no **LATER THAN** after the date of the alleged violation



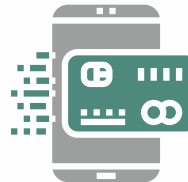
For videos with violations of the rules of stopping and parking, 2 files are required to be sent. The second video should be recorded at least 10 minutes after the first one



THE SENDER IS REQUIRED TO SPECIFY



Full name, address of actual residence, postal code (name of legal entity and location)



Mobile phone number or bank card number and e-mail address (bank account details)

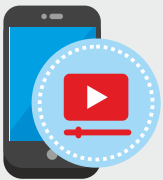


Place, date and time of the violation



IMPORTANT!

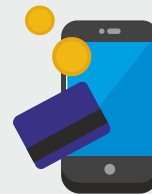
DATA ON THE PERSONS WHO PROVIDED VIDEO RECORDINGS OF VIOLATIONS IS KEPT STRICTLY CONFIDENTIAL



The application is subject to be examined **within three days** from the date of submission



Response to the applicant is sent **within 15 days** in electronic form



The amount of the reward is **automatically credited** to the mobile phone number or plastic card (to legal entities – to their bank accounts) of the sender upon payment of the penalty by the offender
