
1. Structured Funding Dialogues and way forward

- UNDP sees the structured funding dialogues as a means to:
 - Secure a renewed political/financial commitment for a next generation UNDP, in a reforming UNDS
 - Ensure greater alignment of funding with the Strategic Plan 2018-2021 priorities
 - Advocate for quality and predictable funding practice
 - Demonstrate effectiveness, transparency and mutual accountability for results




CONTRIBUTIONS BY FUNDING CHANNEL, 2015-2018

- Total contribution of \$5.2b (preliminary), a 16% (\$717m) increase compared to 2015
- Surpassed the \$5b mark for the first time since 2011
- All funding streams except regular resources experienced an increase compared to 2015, most notably earmarked donor funding (+30%), pooled funding (27%), and government cost sharing (+21%)
- Regular resources increased compared to the previous year for the first time since 2013, albeit modestly (2% or \$12m)
- Share of regular resources deriving from multi-year pledges was 43% - an increase from 29% in 2017

31 million people gained access to basic services in 29 countries

UNDP supported **56 electoral processes**, registering **21.2 million new voters** in **19 countries**







With UNDP's support across 25 countries, **4 million people**

living in or recovering from crisis gained jobs or improved their livelihood




Partnering with the Global Environment Facility and Green Climate Fund resulted in **improved livelihoods for 27 million people affected by climate change**





ESTIMATED PROGRAMME DELIVERY 2018-2021, \$21B*






PROJECT EXPENDITURE BY SIGNATURE SOLUTIONS AND FUNDING CHANNELS, 2018

3. Funding Compact - Implications and follow up

<u>**The Logic:</u>** A successful Compact would create a virtuous cycle, where quality funding leads to efficient systems and impactful results, and vice versa.</u>

lf

- 30% of development related activities by UNDS are funded through core
- Double the share of non-core resources for development activities channeled through pooled and thematic funds
- Sources of funding base is broadened and funding becomes predictable
- RC system gets adequately and sustainably funded...

Then

- More flexible funding to eradicate multidimensional poverty, minimize under-funded areas, and leverage more financing for SDGs
- More funding supporting platforms for inter-agency collaboration and joint results
- More effective long term plans for results and integrated solutions
- The risk of shifting resources from programme to coordination diminishes



3. Funding Compact – progress to build on



Efficiency Gains

- Over 90 cents of every dollar spent went to programmes and services to achieve development results
- •Continued work to identify efficiencies in shared services and increased clustering

Transparency/Visibility

- Country-level Engagement for Visibility with UNDP's Core Funding Partners
- Continue to promote core contributors' investment in UNDP through media channels

Thematic Funding

- Alignment of thematic funding window with SP
- Optimizing performance of Funding Windows
- Increasing visibility and stronger reporting of results and contributors

Pooled Funds

- Advocate for pooled funds as an effective instrument for more joint activities and
- instrument for more joint activities and integrated solutions
- Increase awareness and visibility of pooled funds among UNDP leadership, COs and partners



3. Funding Compact – follow up mechanism



- Determined commitment areas that are on track, in progress, or require action
- Timely and regularly communicate with Country Offices to guide and encourage implementation of compact commitments
- Engage and communicate with Member States on the Compact, including via the Structured Funding Dialogues
