#### 1. Background

The Great Lakes region has historically suffered from cyclical violence that finds its roots in poverty and political conflict. "Intensifying hostility among states in the Great Lakes threatens a return to the regional wars that tore that region apart in previous decades" – the International Crisis Group warned in January 2020, calling for greater and more robust UN engagement in support of Peacebuilding in the region. It is against this background that FAO, UNDP and WFP in both in DRC and Rwanda have developed the project "Creating peace dividends for women and youth through increased cross-border trade and strengthened food security Cross Border" in collaboration with national counterparts in both countries and with the support from the Peace Building Fund.

The project "Creating peace dividends for women and youth through increased cross-border trade and strengthened food security Cross Border" focuses on one of Africa's most critical trading posts linking Western and Eastern Central Africa and the Goma – Rubavu border between DRC and Rwanda, a historical hot-spot of conflict but also key source of resilience in the Great Lakes region. The project contributes to peacebuilding and social cohesion in the DRC-Rwanda border areas around Goma and Rubavu by deepening economic integration through increased cross-border trade, fostering mutual understanding and dialogue between border communities, and strengthening food security, livelihood, and income opportunities, particularly for women and youth.

The project is built on the assumption that if essential impediments to local cross-border trade of agricultural products are reduced, if the capacities of young entrepreneurs in cross border trade development are enhanced and if capacities for agricultural production are strengthened and expanded on both sides of the border, with a focus on the capacities and opportunities of women and young people then, conditions for cross-border trade will improve and cross-border community interaction will foster mutual understanding and trust by providing opportunities for dialogue among social groups around common and mutual economic interests and the increased availability of income and livelihood opportunities will reduce incentives to engage in violence as a means of improving economic circumstances, thus strengthening Peacebuilding.

To achieve this, the project focuses on resolving underlying issues and grievances linked to unequal agricultural production and trade competition on the two sides of the border. Any promotion of agricultural production and cross-border trade needs to be sensitive to the perceived and real concerns over competition between the two border communities. The project also aims at addressing key impediments to cross-border trade by reducing barriers to access to income-generating activities and food supplies for communities on both sides of the border. Harassment and the prevalence of bribes and unofficial payments at the border are among the most serious hindrances to access to markets by small-scale traders. Economic inclusion of women and youth is at the center of this project.

The proposed strengthening of cross-border trade is a key means of economic integration of vulnerable groups, especially women and youth. The focus on supporting small scale traders, primarily young and female, is a way to empower women and youth at the local level, which has been shown to strengthen the resilience of communities and help mitigate risks of conflict. Furthermore, there is significant untapped potential to increase profitability, and thus further consolidate livelihoods, by improving the value-chain of agricultural production. This could have an expanded peacebuilding impact by reducing the gap in growth rate of horticulture production and trade between the DRC and Rwanda sides of the border, and by providing opportunities for collaboration around common economic interests between

small-holder farmers and traders on both sides of the border Under the overall guidance and supervision of Deputy Resident Representative and the Direct Supervision of the Governance Team leader based in Kigali.

DRC-Rwanda Cross Border project: Creating peace dividends for women and youth through increased cross border trade and strengthened food security, aims to address food and economic insecurity at the local level in cross border communities in DRC and Rwanda, as a driver and root cause of conflict and instability in the area. The project aims to strengthen peace building and social cohesion by deepening economic integration through increased cross border trade, fostering mutual understanding and dialogue between border communities and strengthening food security, livelihood and income opportunities particularly for Youth and Women.

This project focuses on most of Africa's most critical trading posts linking Western and Eastern Central Africa, the Goma–Rubavu Border between DRC and Rwanda, a historical hot -spot of conflict but also key source of resilience in the Great Lakes Region. In this context, this joint project (UNDP, FAO and WFP) and cross border (DRC and Rwanda) was developed with funding from Secretary General Peace Building Fund.

Cross border trade is a life blood of Great Lakes, providing critical livelihood and income opportunities for border communities and is focused primarily on the trade of agricultural and livestock products, and so is an essential part of food security. Cross border trade allows vulnerable populations to reconnect with the world and access goods and services that are key for their economic and social recovery. In such environments, trade also helps generate solidarity between border communities and helps in promoting peace and stability

#### 2. Objectives of the study

The government of Rwanda, through MINICOM and with the support of Development Partners (DPs) and other key stakeholders, has identified cooperatives as one of the key vehicles for the mobilization and involvement of a big cross section of border communities in the drive to enhance their livelihoods and social economic status. It is in this context that MINICOM has embarked on an exciting journey of organizing informal Cross Border Traders into cooperatives and building their capacities through training on how best to operate as a cooperative and how to grow the business beyond the sum of each of the individuals. Currently, there are about 98 CBT cooperatives with total membership of more than 5,600. The majority are women. For the last six years, these CBT cooperatives have been supported by government institutions, regional institutions, the donor community and civil society organizations. It is also recognized that the COVID 19 pandemic has also negatively impacted CBT, since early 2020.

It is prudent therefore to examine the current status, capacity and challenges of existing Cross Border Trade (CBT) Cooperatives and develop CBT indicators to measure their progress and the impact of the support provided to them over last six years, with the view to inform the policy makers, development partners and other key stakeholders on clear policy direction for the next phase of intervention.

The study will look at the current situation and challenges for cross-border trade between Republic of Rwanda and its neighbors with a focus on the existing cross border trade cooperatives across the bordering districts, namely; Rubavu, Rusizi, Nyagatare, Kirehe, Bugesera, Gicumbi, Burera, Karongi, Nyamasheke, and Nyaruguru. The aim will be to improve the socio-economic well-being of traders involved in informal cross-border trade within the bordering districts, especially the vulnerable groups e.g. women, youth, PWDs and poor households among the border communities, thus contributing to cross-border exchange and peace building in the region.

The study will cover key measurable indicators to capture the impact of the policy actions that have been taking place for the last six years (2017-2022) and provide detailed report including successful measures, organization of cross-border trade cooperatives, tailored capacity building plan and areas of emphasis, readiness of stakeholder's involvement including support provided, Cross Border Traders' Cooperatives levels and social and economic indicators/measure, etc.

The main objective of the study is to conduct analytical assessment on the existing cross border trade cooperatives across the 10 bordering districts, including their current status and challenges they face, and draw policy recommendations and action plan to enhance their sustainability as well as the wellbeing of their members. Also, the assessment will assist to consolidate more information and facts about operations of the CBT cooperatives in Rwanda and focused on various aspects of the current status of cooperatives in the country. These include, among others, their composition and membership; their location across the country especially in light of the trade potential; their legal status and regulatory compliance; their respective activities, products and value chains; their capacity in terms of capital and human capacity; the impact; the achievements made and the constraints that impede smooth progress and provide recommendations to policy makers on the priorities for trade facilitation.

#### Specific objectives include

- Assess the current status of cross-border trade cooperatives in bordering districts/Rwanda, and cross border trade (flows, prices, products and markets) in general;
- Establish the challenges faced by the cross-border traders and their cooperatives;
- Undertake comprehensive assessment on the organization and management of cross-border trade cooperatives in Rwanda
- Examine by appropriate indicators/measures how cross-border trade cooperatives have helped to improve the socio-economic well-being of their members, growth and poverty reduction;
- Identify and document the scope of the tailored capacity building and other support received by the cross-border trade cooperatives from all stakeholders and Development Partners (DPs) over the last 6 years (2017-2022);

- Assess the readiness of stakeholders including local authorities, civil society organizations and DPs to contribute to promotion and development of Cross Border Traders and their cooperatives;
- To assess the effectiveness, efficiency, impact, and sustainability of various structures operating at the borders to facilitate Small Scale Cross Border traders and their Cooperatives
- Identify the existing skills and knowledge gaps which undermine the proper operations of the CBT cooperatives;
- Design a strategy, including proposed interventions, activities, budget and implementation plan, to address the gaps, challenges and constraints identified by the study, in order to enhance the operations and sustainability of CBT cooperatives and to boost CBT in general.

#### 3. Scope of the study.

The study will cover all 10 bordering districts of Rwanda bordering with DRC, Burundi, Uganda and Tanzania. It will consider respondents from existing CBT cooperatives, some of their members and other key stakeholders.

#### 4. Duty station

The consultant will be based in Kigali, Rwanda, but will travel outside for consultation with relevant stakeholders and beneficiaries. Planned missions outside Kigali will be included in the financial proposal provided by the consultant with all logistics and costs included.

#### 5. Key deliverables.

The study is expected to be undertaken within the period of November-Dec 2022. The total number of estimated days is 30 working days. The assignment requires traveling to the border districts of Rwanda to meet the key stakeholders in person. These milestones, as laid out in the table below, are to be achieved within the contract period.
