UNDP KENYA IN PARTNERSHIP WITH THE EUROPEAN UNION (EU)

Partners at Core (Washirika wakuu)

The European Union (EU) is one of the key donor partners and has been supporting UNDP's development offer in Kenya to deepen democratic governance, strengthen civil society engagement, enhance access to justice and reinforce cross-border regional cooperation between Kenya and Ethiopia.

PROGRAMMATIC APPROACH

- Contributed to enhanced coordination capacity of the Independent Electoral and Boundaries Commission (IEBC) and Civil Society Organizations (CSOs) through civic education which resulted to an **increased number of registered voters in the 2022 General Elections from 19,611,423 in 2017 to 22, 120, 440 in 2022. Female registered voters increased from 9.4 million (47%) in 2017 to 10, 865, 560 (49.12%) in 2022.**
- Together with UN Women, supported women's empowerment efforts during elections. In the 2022 General Elections **seven out of 47 Governors were elected (up from 3 in 2017) while 26 female MPs were elected out of 290 (up from 22 in 2017).** The number of **women appointed to Cabinet Secretary positions have increased from 21% in the previous Government to 25.6% in 2022.**
- Enhanced IEBC'S capacity in dispute resolution mechanisms to effectively handle and manage disputes during elections. **A total of 162 nomination-related disputes were resolved through IEBC's Dispute Resolution Commissioners.**
- A total of **560,897 (242,175 Male; 318,722 Female) direct beneficiaries and an estimated 6,239,982 indirect beneficiaries reached with legal aid and assistance** using various strategies and approaches.
- Capacity of over 372 staff from 31 Amkeni Wakenya grantees on project and financial management enhanced** through training on financial management, Human Rights Based Approach (HRBA) and Communication and Knowledge Management.
