We had a peaceful and happy life prior to the floods which drastically changed after the 17<sup>th</sup> of July 2018, when forty-two households were wiped away by the GLOF. Everything changed for us as our houses were completely destroyed, but luckily, no human lives were lost. The work done by the GLOF-II Project in our valley is commendable, starting from surveys carried out in 2019 to actual on-ground implementation, from mock drills to channelization (of irrigation systems), everything has been done timely. Protective works have already been initiated. 2500 trees planted in Badswat in April 2021 have also contributed positively to the environment. The construction of the CBDRM Centre will also be completed by the end of this year. I am again very thankful to GLOF-II for executing this project smoothly.
