# OUR WORK

Over two consecutive Integrated Governance Programme cycles, backing from the UK has enabled UNDP to support Maldives to empower independent institutions, transform the judiciary, legal and justice sector, and amplify the voices of civil society and media. We have provided formative and sustained support to decentralization and local governance, and in efforts spearheaded to advance women's empowerment and gender equality. The partnership has relentlessly prioritized building institutional and human resources capacity in accordance with global development agendas, international standards, and best practices. It is premised around the critical importance of coordination, dialogue, and community engagement to foster long-term stability and peace in the Maldives.

# OUR Impact

#### **Civil Procedure Code**

Drafting and ratification of the first Civil Procedure Code of the Maldives. As part of our support for continuous judicial education, the Judicial Academy has trained over 155 Judges and 305 legal staff nationwide on the administration of the Civil Procedure Code.

#### **Justice Sector Stocktaking**

A pledge matrix developed to conduct the justice and legal sector stock taking exercise is being used by the Attorney General's Office to consult with donor governments and lobby for their support to the Justice Sector.

#### **Judicial Performance Evaluation Tool**

Ensures transparency in the assessment of Judges performance contributing to the enhancement of building public trust and confidence in the judicial system. Performance evaluations of 47 Judges (incl. 3 women Judges) from around the country.

#### Integrated Case Management System of the Judiciary

Digitalization support to the courts. E-case management, court hearings, applications for court services, knowledge exchanges and learnings offered to Maldives Judiciary.

#### Support to fiscal decentralization

Work is ongoing to formulate Local Company Authorities Model under the local councils. This would include development of manuals and capacity building of councils on this model.

#### **Judicial Education**

Developed Maldives' first regulation on legal education. Conducted the standard setting study to support the formulation of the country's first national bar exam. Developed minimum standards for all undergraduate and postgraduate law programs. Judicial training needs assessment conducted and revision of judicial curriculum.



## STRENGTHENED Synergies

#### **Global UK Partnership with UNDP**

The global UK partnership with UNDP aims to achieve a range of Sustainable Development Goals by leveraging the expertise, resources, and networks of both entities. The partnership recognizes that economic prosperity is essential to achieving broader development goals, such as reducing poverty, promoting social inclusion and achieving climate resilience. To this end, the UK and UNDP are working together to unlock economic potential and increase access to markets and opportunities for people, enhance private sector engagement, unlocking investments and fostering innovation and entrepreneurship, with a key focus on addressing pressing global challenges such as climate change.

#### **Climate Finance Network**

Project supports efforts to promote and scale climate finance innovations: to develop a SDG climate investor mapping report, and to collect investment relevant data on key sectors of the Maldives economy.

IN THE WORKS:

 Climate Investor Mapping Report has been compiled - will be the first report which systemically maps out key Maldives industries, identifies potential broad investment opportunity areas and business models which will positively contribute to the achievement of SDGs (in particular climate action) in the Maldives.
