Summary: This project supports the prevention and mitigation of spread of COVID-19 among the Indigenous and Tribal Peoples (ITPs) by improving the provision of sanitation and hygiene facilities to these vulnerable populations and adopting a strategy of Information, education, and communication which is culturally sensitive and in the appropriate language comes along with the provision of facilities.

The project is meant to design strategies to mitigate the social and economic impact of COVID-19 among the ITPs and pilot interventions to stimulate resilience by building back stronger and greener informed by the result of the Digital Rapid Socioeconomic Impact Assessment (RD SEIA), with special focus on developing opportunities for women.

Outputs:

- Provision of water installations (through RWHs/water tank system) with portable hand washing stations and supplies (such as soap and dispensers)
 - a. Stand-alone hand wash stations installed at Bronsweg (2); Atjoni (2).
 - b. Handwashing station connected to water supply network: Matta (1), Donderskamp (2), New Aurora (2), Pikin-Slee (2), and Sara Creek (2)
 - c. Water supply system rehabilitated:
 Donderskamp, Kalebaskreek, New Aurora,
 Pikin Slee, and Sarakreek
- Awareness building, education and mitigation of COVID-19 among ITPs; X villages provided with information/prevention of COVID-19 taking into account language and culture
 - COVID-19 awareness and information sessions held in various Indigenous and Tribal village taking into account local languages and culture
- 3. Income generating opportunities for ITP women to promote economic recovery:
 - 50 Indigenous women from 30 villages and 28 Tribal women from 22 villages in Suriname received skills training towards improving their livelihoods as part of recovery.

The women were trained in face mask production and also received sewing machines and related materials for production of face masks.

 A total of 15 indigenous women from Washabo and Piking Poika and 29Tribal women from the villages Nieuw Ganze and Birudu matu village in Suriname received support to pilot crop production towards improving their livelihoods as part of recovery from the pandemic

Project Title: Joint Programme - Leaving No One Behind, Building Resilience, and Improving Livelihoods of Indigenous and Tribal Peoples (ITPs) in Suriname

Time Frame: 2022-2024

Financial Envelope: USD 280,000.00

Donor: Joint SDG Fund

Partners: Ministry of RegionalDevelopment and Sport, Ministry of Social Affairs and Public Housing, VIDS, KAMPOS, and UN Agencies, UNICEF, UNFPA, FAO and UNWomen

Summary: This Joint Programme (JP) is aimed at integrated policy solutions to enable inclusion, build resilience, and improve livelihoods among Indigenous and Tribal Peoples (ITPs) in Suriname. This JP aims to address the multi-dimensional vulnerabilities of Indigenous and Tribal Peoples in Suriname through an overarching, integrated policy framework aimed at improving the quality of life for ITPs and a series of small Integrated Rural Development Initiatives (focused on essential services and employment) to test these policy interventions in a participatory manner.

The integrated policy is in alignment with the International Conventions, Treaties and Agreements on the Rights of Indigenous Peoples such as the ILO Indigenous and Tribal Peoples Convention, 1989 (No. 169), the UN Declaration on the Rights of Indigenous Peoples of 2007 (UNDRIP), and the outcome document of the 2014 World Conference on Indigenous Peoples. This is all in-line with the "Leave No One Behind" principle and contributes to the achievement and acceleration of SDGs 1, 2, 5, 16 and 17. This Joint Programme is aligned with Priority Area 2 of the UN MSDCF 2022- 2026 – "Equality, Well-being and Leaving No One Behind".

Summary: This initiative is launched in partnership with the E-Gov Department and technical assistance from UNDP's Accelerator Lab. The objective of this initiative is to assist the government of Suriname to undertake an assessment to status of the country's digital readiness.

The UNDP Digital Readiness Assessment is a surveybased tool to provide rapid, high-level insights into a country's digital strengths and opportunities. It is intended to serve as an "entry point" for increased engagement between governments, UNDP Country Offices, a broad range of UNDP experts, and other international development partners. The Digital Readiness Assessment also aims to improve coordination and clarity to drive a whole-of-government and whole-of-society approach to digital transformation. This is crucial in achieving digital inclusion, ensuring that no one is left behind from the potential of digital, and enabling countries to leverage digital to achieve the Sustainable Development Goals

Project Title: National Digital Strategy Roadmap and Implementation Plan

Time Frame: July – December 2022

Financial Envelope: USD 50,000

Donor: UNDP Strategic Plan Enablers

Partners: E-Gov Department

This project provides technical and financial support to the development of a National Digital Strategy Roadmap and Implementation Plan. This includes broad-based, cross-sectoral stakeholder engagement, mapping of internal and external funding opportunities to drive digital transformation and to prepare the strategy and implementation plan that will address the recommendations set out in the DRA Tool Final Report.

Focus is given to shaping and implementing strategies – to provide coherence and direction across key digital transformation priorities (including digital infrastructure, a national data governance strategy, and a digital skills strategy). A number of related strategic initiatives within government - including improving monitoring, learning, and evaluation capacities to strengthen the country's existing digital foundations; and working to break down siloes between departments and delivery teams are also supported.
