BACKGROUND AND CONTEXT

Over the past two decades, the Lake Chad Region has been severely impacted by the Boko Haram insurgency and other related conflicts. The impacts range from massive internal and cross-border displacement, the destruction of the social fabric and property, human rights abuses, disrupted public services, and limited capacities of government institutions. In response to the security and conflict challenges, the governments of the four riparian countries established a joint military task force called the Multinational Joint Task Force in 2015 to launch a coordinated military counter-offensive against Boko Haram. The establishment of the Taskforce was later followed by the development of a Regional Strategy for Stabilisation, Recovery and Resilience by the Lake Chad Basin Commission with the support of the African Union and UNDP in 2018. The Strategy provides a robust framework for addressing the region's complex and urgent security, humanitarian, and development challenges. It recognises the need for a comprehensive, multi-sectoral, coordinated set of sub-national, national, and cross-border efforts for the region's long-term stabilisation, recovery, and resilience.

The Strategy's (RS-SRR) nine (9) pillars and forty (40) strategic objectives have provided the frame for developing initiatives and programmes to support the implementation of the Strategy.

It also guided the localisation of the Strategy through the Territorial Action Plans (TAPs) in each of the eight states/regions/provinces most affected by Boko Haram in the LCB region. The RS-SRR build on inclusivity, local ownership, and a New Way of Working. Over the past years,' the RS-SRR has become a locally anchored and multi-partner effort that has led to rebuilding the social contract between the government and communities by providing essential infrastructure and basic services, security, and livelihood opportunities for affected communities. The Strategy has also recorded success in developing and harmonising regional policies, sharing best practices and producing evidence-based research for policy influencing.


The Governors' Forum, an integral part of the RS-SRR, has served as the most important political platform for cross-border and regional interaction with various stakeholders and interlocutors. Over the years, the Forum has established itself as a platform for stakeholder exchanges and the main platform for political dialogue in the LCB. Since the last Governors Forum in Yaoundé, Cameroon, in October 2021, there have been significant contextual developments and shifts in the conflict pattern in the region. The MNJTF has recorded significant success in the fight against Boko Haram groups by launching two military operations: Operation Yancin Tafki II in December 2021 and Operation Lake Sanity from March to June 2022. Combined with the rebuilding efforts, these operations have led to the rebuilding of new communities and restoring the social order in affected communities. It has created opportunities for displaced persons and refugees to return to their homelands with dignity.



The combined impact of the death of Shekau in May 2021 and the upscale military offensive has triggered massive surrender and the defection of Boko Haram associates. The surrender has, in turn, created a challenge in ensuring comprehensive and effective management of their exit from the Boko Haram groups and an opportunity for a community-centred reintegration process, which recognises the role of transitional justice in the reintegration process. The impact of the insurgency on communities and the discontent from the killing led to the emergence of vigilante groups in some countries in the region. These groups have gained recognition from communities, government and security actors but have also come under criticism for potential human right violation. Moreover, the future of the vigilante groups post-insurgency remains unaddressed.

After nearly 13 years of conflict and insurgency, the Boko Haram group continues to unleash violence and attack on communities, leaving around 3.1 million internally displaced (IDPs), including 2 million in Nigeria alone. The Governors and Governments of the region have prioritised the return of IDPs and refugees to their homelands. The Forum will provide the best opportunity for stakeholders, including Governors, UN entities and local CSOs, to interrogate options for localised and comprehensive solutions for IDPs and Refugees.

The shrinking of the lake and the changes in the climate and environmental conditions have led to the struggle for scarce resources, inter-communal conflict, youth unemployment and restiveness. These urgent issues must be addressed locally, regionally, and globally to strengthen community resilience and pathways for sustainable living. Similarly, whilst the insurgency caused by Boko Haram and other factions has led to severe regional humanitarian and development challenges, the conflict between farmers and herders continues to create tension between communities.



OBJECTIVES

Under the overarching theme of "New Opportunities for Peace in a Shifting Security Context", the Fourth Lake Chad Basin Governors' Forum objectives are to offer:

Specifically, the forum seeks to:

- 1. Enhance understanding of the emerging security trends in the region and the implications of the ongoing efforts to complete the restoration of state authority.
 - 2. Take stock of the progress of the five years of the RS-SRR and propose key strategic priorities for the next phase of the RS-SRR.
 - Discuss pathways for community reintegration and transitional justice in the region.

- 4. Examine the role and implication of Vigilante Groups and Government-affiliated non-state security actors in the region
- Find ways of scaling up and building partnerships for solutions to the situation of the forcibly displaced (refugees and IDPs).
 - 6. Provide options for Climate Security and Natural Resource Management in the region.

7. Examine the agropastoral, farmer-herder dynamics, and implications for community resilience and sustainable peace in the LCBC Region

EXPECTED OUTPUTS

Stakeholders will agree on a shared understanding of the trajectory of the security situation in the Lake Chad Basin region and proffer different programmatic and policy pathways to long-term Stabilization, Peacebuilding and Sustainable Development in the region.

METHODOLOGY FOR THE 4TH LAKE CHAD BASIN GOVERNORS' FORUM



Drawing from lessons of the past Forum and to ensure broader participation of critical actors in the Forum, the 2023 Governors' Forum will consist of three distinct but integrated parts:



The first part, a "pre-forum", consists of pre-forum events, including the CSO Forum to be implemented by partners. The pre-forum events will be self-organized by the entities whose entries have been accepted. The outcomes of the pre-event will feed into the Forum discussions.



The main forum will be a three-day event split into thematic sessions where the Governors will serve as the main panellists alongside international experts and local stakeholders. The Governors will also have closed-door deliberations.



The third part is the technical follow-up on the key recommendations and decisions of the Forum between February –March 2024 to take stock of progress and facilitate actions.


