

Annex v. Evaluation Plan (2023- 2025)

The Evaluation Plan of this PPF includes all mandatory evaluations as per the UNDP evaluation guidelines and will be updated on an annual basis at the beginning of each year. The Evaluation Plan consists of thematic, portfolio and project evaluations to measure the extent to which UNDP/PAPP is achieving the intended results at different levels. UNDP/PAPP aims at including at least one thematic and/or portfolio evaluation under each PPF outcome, in tandem covering all three UNDP Strategic Plan outcomes. The need of including both project as well as higher-level evaluations shall ensure that UNDP/PAPP collects evidence-based information to both adjust its projects and programme, inform decision-making, future programming and achievement of goals as per the UNDP/PAPP PPF 2023-2025 and UNDP Strategic Plan 2022-2025.

Based on lessons learned, UNDP/PAPP will initiate evaluations early to mitigate delays in finalizing evaluations and management responses. Furthermore, UNDP/PAPP will ensure constraint factors are fully considered during annual planning and implementation. The evaluation plan will be reviewed on a yearly basis and any required adjustments would be made accordingly and reflected in the ERC. For future projects approved within the framework of the new cycle, relevant evaluations will be integrated in the Evaluation Plan as they arise, in compliance with UNDP regulations.
