Brazil CPD 2024-2027- Evaluation Plan Rationale

CO's Brazil evaluation plan for the CPD 2024-28 demonstrates an appropriate and comprehensive coverage of its programme portfolio and is aligned with the country's priorities. The plan includes all mandatory evaluations and contributes to the accountability, learning, and strategic results of the office.

On a macro level, the planned evaluations are directly related to the three directions of change outlined in UNDP's Strategic Plan 2022-2025, contributing to the delivery of signature solutions. Moreover, it supports the outcomes agreed in the UNSDCF, signed in 2023, contributing to the country's development priorities.

The distribution of evaluations in the plan reflects the relevance of government cost-sharing projects in Brazil. The 8 evaluations planned under Outcome 4 (related to peace, justice, and governance) evidences the growing participation of the Brazilian Judiciary System in our portfolio, especially the partnership with the National Justice Council (CNJ).

The evaluations planned for Outcome 3 (4 in total) and GEF projects (7), reflect Brazil's leading role in climate and environmental development projects. As this relevance is expected to return to previous levels and possibly grow in the upcoming years with the elected government in 2022, accurate data and recommendations are crucial.

Evaluations under Outcome 2 (4) indicate CO's Brazil significant contribution to the institutional strengthening of Brazilian institutions to deliver effective public policies and social protection schemes, ensuring that no one is left behind.

For Outcome 1, 2 evaluations support assessing our actions toward sustainable and transformative economies. One of the evaluations will be thematic, focusing on UNDP's Brazil support towards economic transformation, including projects with the following counterparts: the Ministry of Economy, the Ministry of Planning, and the Administrative Council for Economic Defense.

Overall, the plan's 26 evaluations provide a holistic approach, including partners involved and evaluation budgets as required.
