

ANNEX B: FULLY COSTED EVALUATION PLAN

In line with the Country Program Document cycle, the present evaluation plan covers the period January 2024 – December 2028 (5 years). It was developed through a participatory process with key national stakeholders and approved by both national counterpart and UNDP management. It considers the lessons learned from the implementation of the previous evaluation plan and complies with the various requirements of the UNDP evaluation policy described in the new guidelines. Besides, the choice of evaluations mentioned in this evaluation plan are mainly guided by the need to (i) comply with the new UNDP Evaluation guidelines, (ii) strengthen accountability to partners and donors, and (iii) draw the appropriate lessons in order to better deliver through the portfolio approach and to better position the country office in some strategic thematic, including governance, clean and affordable energy where UNDP is willing to strengthen its comparative advantage. These evaluations will stimulate and strengthen communication and knowledge sharing with Government, UNCT, national partners, target groups, beneficiaries, and media, ensuring learning and UNDP’s transparency and accountability for results and resources. This evaluation plan will be reviewed on an annual basis to ensure that evaluation of new projects, including GEF/GCF projects are taken into consideration, in line and compliance with mandatory thresholds for project evaluations and/or the cost-sharing agreements with partners.
