

ANNEX B. GUINEA FULLY-COSTED EVALUATION PLAN

The evaluation plan aims to provide a coherent balanced between project, outcome level and thematic evaluation to provide the country office with the needed information on progress towards the results and lessons learned to inform its programming and decision making.

Thematic evaluations will be conducted on the governance of the mining sector, Gender equality and Empowerment, access of rural communities to clean and sustainable energy and Youth and Women Inclusion.

A mid-term evaluation of the country programmed is planned for April 2026 and will cover all results. This evaluation will identify progress and lessons learned across outcomes in the implementation of the country programme, provide recommendations, and direction for further implementation of the CPD.

Projects evaluations are planned according to agreements with donors and according to the evaluation guide. In accordance with the UNDP Evaluation Guide, the evaluation plan will be reviewed annually to verify and update the schedule of planned evaluations, making any necessary adjustments in agreement with the regional evaluation advisor.
