GOAL 1:

Polices and mechanisms in place for equitable access to finance and decent employment, create opportunities, especially for women, youth, and other vulnerable groups.

GOAL 2:

The adoption and dissemination of digital and green technologies are supported to create decent jobs and build skills.

GOAL 3:

Local and regional authorities and stakeholders are empowered to lead local sustainable development and to build more resilient, economically sustainable communities.



PRIORITY AREA 2



ACCELERATING CLIMATE ACTION
AND NATURE-BASED SOLUTIONS

By 2027, the Kyrgyz Republic has started the transition to low-carbon development and risk-informed climate resilience, contributing to people's fair and equitable access to ecosystem benefits and to empowerment of vulnerable communities in the governance of natural resources and disaster prevention.

GOAL 1:

National and sub-national government has improved capacities to implement low carbon, people-centered climate change mitigation and adaptation actions, utilizing efficiency-enhancing measures in access to clean sustainable energy and water.

GOAL 2:

National and sub-national mechanisms and systems are in place to introduce solutions for improved conservation of biodiversity and management of natural resources.

GOAL 3:

National, institutional, legal and policy frameworks are in place for risk-informed development and building resilience to disaster and climate risk, including through transboundary cooperation.

PRIORITY AREA 3

STRENGTHENING INCLUSIVE,
ACCOUNTABLE AND
DEMOCRATIC GOVERNANCE

By 2027, all people in the Kyrgyz Republic enjoy the benefits of fair and accountable democratic institutions that are free from corruption and apply innovative solutions that promote respect for human rights and strengthen peace and cohesion.

GOAL 1:

Capacity of national and local governance institutions strengthened to deliver responsive and accountable public services to all without any discrimination.

GOAL 2:

Justice system and national human rights institutions are strengthened to ensure equal access to justice and due process, reduce corruption, promote the rule of law and human rights for conflict prevention and sustaining peace to address drivers of fragility.

GOAL 3:

Civil society and vulnerable groups, especially women, youth and people with disabilities, benefit from strengthened and inclusive social dialogue and are empowered to equally participate in national and local decision-making and development, fostering resilience.





STRENGTHENING HEALTH SYSTEM



UNDP will continue strengthening the national health system for stronger human immunodeficiency virus (HIV) and tuberculosis responses and this includes helping develop capacities for sustained future service delivery in cooperation with national partners, UNAIDS, WHO, USAID.

HIV and TB epidemics remain acute problems for Kyrgyzstan's health care system. Between 2013 and 2019, the number of registered HIV cases in Kyrgyzstan doubled (9135 in 2019). The HIV epidemic in the country continues to be concentrated among key population groups, with an increase in the share of women diagnosed. 70% of registered cases are due to sexual transmission. Concerning TB, Kyrgyzstan is one of the 30 high burden countries for drug-resistant TB, with around 29% of newly registered cases and 68% of previously treated cases that are drug-resistant (according to data from the WHO). These problems have become even more urgent to address following the COVID-19 pandemic, which, as scientists have warned, will have negative effects on TB and HIV control programs around the world.

The Sustainable Development Goal 3 set by the UN is to ensure healthy lives and promote well-being for all, at all ages, including putting an end to the AIDS and TB epidemics by 2030. To this effect, UNDP has been effectively implementing GFATM grants since 2011.
