#### ANNEX 1: SCHEDULE OF REQUIREMENTS

#### **Technical Specifications for Goods and Services:**

The TSP-MOLD project "Supporting The Ministry of Local Development in Decentralization and Integrated Local Development with special emphasis on Upper Egypt" is seeking the services of a vendor to provide comprehensive medical insurance plans across Egypt, for around 35 persons. The duration of the required services is one year. The proposed medical insurance plans will undergo revisions and receive final approval from the Project Team.

# It is crucial that the vendor possess a minimum of five years of experience in administering group medical insurance plans.

It is important to highlight that payments to the chosen vendor will be disbursed on a semi-annual basis. Specifically, the first installment will be paid upon the signing of the contract, and the second installment will be issued after the completion of the first six months of the contract term.

Selected vendors are required to share their medical networks with the Project, ensuring that full coverage is maintained for services both within and outside these networks. It is advisable for vendors to promote the accessibility of their preferred medical networks within the plan.

Selected vendors are required to submit a monthly report detailing the status of consumption. This will ensure that the project remains informed about the amount consumed relative to the agreed-upon ceiling.

Selected vendor must deliver the medical insurance cards within 3 days after Contract signature. Medical Inurance cards should be be delivered to the following address: MoLD premises in the new administrative capital, 3rd floor, inside Ministry of Local Development).

\* All payments are exempted from VAT, as the project is exempted from VAT. Letter from the Egyptian Tax Authority (ETA) will be provided by the project to the selected vendor.
