INTENDED TRANSFORMATION



- **Effective CRVS Adoption:** A robust, inclusive digital CRVS system established with a focus on user-friendly design, simplicity, advocacy and capacity building to ensure widespread adoption
- **Government Initiative for Accessible Service Redesign:** A dedicated government initiative launched to redesign administrative processes in a user-centred way across specific sectors to deliver interoperable, unified, accessible digital public services at the local administrative level.
- **Data-Driven Inclusion:** Administrators make use of CRVS-based population analytics to continuously identify access barriers faced by vulnerable groups in utilizing public services. Dedicated user feedback mechanisms and digital accessibility guidelines help formulate evidence-based policies and innovations to rectify exclusion gaps and fulfill the government's constitutional responsibility for equitable development.

EXPECTED PROGRAMME RESULTS



- Fully digitized and streamlined civil registration processes tested in select divisions covering urban, rural and estate sectors resulting in **halved registration times**.
- **A functioning interoperable CRVS database and system** adopted by 3 key government entities and generating real-time population statistics reports that increase resources directed at / available to vulnerable populations.
- The target population in each of the selected divisions will have knowledge of, access to, and skills for use of digital civil registration services that will allow for an improved quality of life.

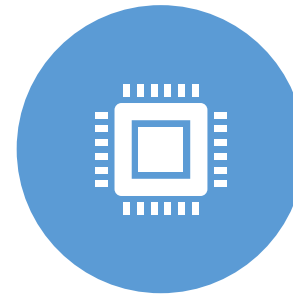
Improving National Data Infrastructure and ownership framework

IMPACT ON THE HEALTH SECTOR



- Strengthening the CRVS system supports multiple sectors, and health is a key sector in this process.
- A well-functioning CRVS system which provides high quality and timely information is essential for understanding the health status of the population and guide health policy and planning.
- Mortality is a key component of the system and ensuring the accuracy of cause of death is also critical for the health sector to understand the disease burden and to assess rapidly evolving health threats.
