I. EXECUTIVE SUMMARY

The Afghanistan Integrity Initiative (AFII) project is unique in the sense that it's in its initiation phase. The sole objective is to formulate and initiate the mobilization of resources for UNDP's new Anti-Corruption project. Consequently, desk review, counterpart consultations as well as coordination with donors have continued to constitute The Afghanistan Integrity Initiative's activity focus in the third quarter of 2013.

Key achievements in this quarter encompass:

- The completion and pre LPAC of the draft project document of the forthcoming Afghanistan Integrity Initiative
- The revision of the project document in line with suggested changes put forward at the pre LPAC
- Extensive discussions with government counterparts and civil society organizations to ensure a strong reflection of stakeholder priorities in the finalized project document
- The project has continued to be presented to a larger donor audience to evince general interest and possibility of support

The report shows that AFII partially achieved the output targets of formulating the project document and initiate the mobilization of resources for the project.

The report further shows that AFII by the end of the 3nd quarter had disbursed a total of US\$ 341,708 (provisionally).

II. **RESULTS**

A. OUTPUT 1: The Afghanistan Integrity Initiative (AFII) project document approved and sufficient resources mobilized

This output contains two indicators:

- A) Project document drafted and presented at a pre-LPAC meeting
- B) Level of resources to implement the project mobilized

Status:

- A) A finalized draft project document was completed in June 2013 and was presented before the Pre-LPAC meeting in July 2013. The Chief Technical Advisor incorporated the pre LPAC comments and finalized the project document. The project document was subsequently sent out for a final round of consultations with national counterparts in order to cement government buy-in and ownership. Intense resource mobilization and project support is anticipated to be secured following project finalization in the 4th quarter of the year. In light of drastically decreased funding availability from internal UNDP sources, funding will need to be mobilized almost exclusively from external sources. AFII's resource mobilization strategy will be based on approaching bi-lateral donors together with government counterparts to signal strong stakeholder buy-in and sustainability of project objectives.
- B) The key government counterparts that have been engaged in the consultation and project document formulation process are the Office of the Senior Minister, the Ministry of Education, the Ministry of Justice, and the Supreme Audit Office. A final round of consultations is still required to secure the Ministry of Justice's buy-in to the project. All other government counterparts have agreed to the final project content.
- C) No funding committed AFII donor has been to at this stage. The Chief Technical Advisor has conducted presentations of the project and discussed funding prospects with representatives from the donor community; in particular donors representing AusAID, Japan, and Norway have been consulted. They all expressed interest in the project and are awaiting the signed project document in order to review it thoroughly and ultimately decide on funding support. Follow up meetings with detailed project discussions for possible funding support will continue with the broader donor community once the project document has been signed by government

counterparts following the completion of the LPAC meeting, which is expected to take place in the first half of November.

EXPENSES FOR THE QUARTER

During the third quarter of 2013, a total of US\$ 341,708 was spent for this output. For more details, please refer to annex on page 11 for details.

III. GENDER SPECIFIC RESULTS

IV. PARTNERSHIPS

In response to the magnitude of the corruption problem and the anticipated decrease in bi-lateral engagement as Afghanistan enters the transformational decade, UNDP and UNODC seek to elevate and strengthen their anti-corruption profiles by deepening their inter-organizational collaboration through a mutual anti-corruption partnership framework. This is sensible as the comparative advantages of UNDP and UNODC are naturally complementary and lend themselves to collaboration. While UNDP's technical strength is predominantly geared towards prevention, UNODC is uniquely positioned with law enforcement and criminal justice expertise. The partnership will build on this natural complementarity which is practically reflected in a sample of anti-corruption activities outlined in a draft "UNDP and UNODC Anti-Corruption Cooperation in Afghanistan: An Umbrella Framework" for future collaboration.

V. ISSUES

A preparatory Local Project Approval Committee (LPAC) took place on 17th of July 2013. Following a final round of consultations with buy-in from the Ministry of Justice the LPAC proper is scheduled for the first half of November 2013.

VI. RISKS

The biggest project risk is that sufficient resources for full-fledged project financing won't be mobilized from external donor sources due to the overall decrease of aid budgets experienced by most major donors. This decrease is expected to be particularly challenging for Afghanistan which has experienced unusually high external resource availability over the past 10 years. Mitigating measures have been related to designing the project based on lessons learnt from the ACT project, as well as based on realistic ambitions with reasonable objectives.

VII. LESSONS LEARNED

The development environment of Afghanistan is highly volatile which requires any new project to be formulated with a high degree of realism in scope. Based on lessons learnt from the ACT project AFII has accordingly been formulated with realistic ambitions. In contrast to the ACT project AFII has also been developed following extensive consultations with government stakeholders to ensure not only a strong initial project buyin, but also continued stakeholder support after the election irrespective of change in institutional leadership.

VIII. FUTURE PLAN

The plan for quarter 4 is to complete the project document and mobilize a minimum of 50% of required resources for 2014. Given the current level of the donors' interest and the size of the proposed budget for the project (\$4 Million for 2014); we expect the target to be met.
