INTRODUCTION

On 27 June 2014, the Association Agreement was signed between the European Union (EU) and the European Atomic Energy Community and their Member States, of the one part, and Georgia, of the other part (hereinafter referred to as the Association Agreement). The Parliament of Georgia (hereinafter referred to as the Parliament) ratified the Association Agreement with 123 votes in favor and zero against on 18 July 2014. The Association Agreement entered into force provisionally on 1 July 2014, and fully came into force on 1 July 2016, after the EU side (the European Parliament and the EU Member States' legislative bodies) completed the ratification process.

The Association Agreement is composed of two main parts: a political part, and Deep and Comprehensive Free Trade Area (DCFTA) part. According to the Association Agreement, Georgia will have to ensure approximation/harmonization of national legislation with EU legislation (*acquis communautaire*) within the period specified. It should be noted that this is a dynamic process of approximation. The agreement is concluded for an indefinite period, though the dates by which Georgia's legislation should be approximated/harmonized with the relevant EU regulations are specified. The Association Agreement includes the following acts: regulations, directives, decisions and recommendations.

This action plan aims to promote the implementation of the Association Agreement by the Parliament, and to determine strategic goals, objectives and specific activities of the Parliament that relate to the oversight and legislative activities, and to communicate to the population about the above-mentioned issues in the process of the implementation of the Association Agreement.

The action plan is based on a needs analysis, from which the committees of the Parliament that are directly engaged in the process of the implementation of the Association Agreement before the expiration of the term of the Parliament of the 9th Convocation (autumn 2020) have been identified. Needs assessments and action plans were prepared for each committee, based on which this document – 2019-2020 Action Plan of the Parliament of Georgia for the Implementation of the EU-Georgia Association Agreement – has been written.

This document was prepared under the joint EU and UNDP project “Strengthening the System of Parliamentary Democracy in Georgia.” It was developed by representatives of relevant committees of the Parliament with the support of project consultants.

ROLE OF THE PARLIAMENT OF GEORGIA IN THE IMPLEMENTATION OF THE ASSOCIATION AGREEMENT

The Constitution of Georgia and the Rules of Procedure of the Parliament of Georgia determine constitutional prerogative, according to which the Parliament shall carry out parliamentary oversight and determine the domestic and foreign policy of the country. Statutes of some committees of the Parliament (e.g. the Committees on European Integration, the Environmental Protection and Natural Resources Committee, and the Sector Economy and Economic Policy Committee) define that the Parliament and its committees support both Georgia's integration in the EU and EU institutions, and the timely and effective implementation of the Association Agreement and Association Agenda.

Furthermore, the role of the Parliament in the implementation of the Association Agreement is additionally defined directly by Articles 410 and 411 of the Association Agreement itself. Based on these articles, the Parliament shall exercise oversight over the implementation of the Association Agreement, prepare recommendations and present them for execution to the Government of Georgia (GoG) and the relevant EU institutions. The Parliaments of the 8th and 9th Convocations have been convening the committee hearings with certain regularity, however without predefined terms related to the Association Agreement, the DCFTA and the fulfilment of obligations undertaken by Georgia under the Visa Liberalization Action Plan. Furthermore, for 2014-2017, the Parliament was defined by the GoG as one of the significant actors, and as the oversight body for the implementation of a communication strategy regarding EU integration issues. The above-mentioned function of the Parliament is preserved by the 2017-2020 Government Communication Strategy on Georgia's EU and NATO Integration approved by the GoG. According to this document, the Parliament monitors the implementation of the strategy through six-month reports and annual reports.

Through the implementation process of the Association Agreement, to ensure cooperation of legislative and executive authorities, it is important for the Parliament to be present in the working process of the Government Commission on the EU integration, the basic task of which is to support the process of EU integration and the coordinated work of separate institutions in this regard.

COMMITTEE ON EUROPEAN INTEGRATION OF THE PARLIAMENT OF GEORGIA

The Committee on European Integration has an important role to play in the process of Georgia's integration with the EU. Through its legislative and oversight function, the Committee facilitates the integration of Georgia in the EU and EU institutions. The Committee oversees timely and effective implementation of the Association Agreement and Association Agenda. With this purpose in mind, the Committee oversees the approximation process of Georgia's national legislation with relevant EU legislation, monitors the fulfilment of obligations undertaken by Georgia in relevant cases, plans and conducts joint events, hearing of reports and organizes consultations with civil society in close cooperation with sectorial committees.

The Committee on European Integration leads the work of the EU-Georgia Parliamentary Association Committee, established under the Association Agreement, and the work of the delegation of Georgia at the EuroNest Parliamentary Assembly. The Committee also participates in the work of

the Conference of Parliamentary Committees for Union Affairs of Parliaments of the European Union (COSAC).

The Committee on European Integration promotes cooperation between executive and legislative branches of government on issues relating to European integration and the Chair of the Committee participates in the work of the Government Commission on EU integration.

The Committee also carries out informational and educational activities aimed at promoting the EU integration process. In this regard, the Committee is the main party responsible for the implementation of the Communication Strategy and Action Plan of the Parliament of Georgia on EU integration. The Committee cooperates with other committees of the Parliament and relevant structural units to accomplish these tasks.

SECTORIAL COMMITTEES OF THE PARLIAMENT OF GEORGIA

A desk study revealed that, under the Association Agreement, Georgia is committed to harmonizing its national legislation with at least 346 EU directives, 213 EU regulations, 57 EU decisions and 31 EU recommendations. It should be noted that during the 9th Convocation of the Parliament, Georgia must fulfill half of the obligations undertaken.

The table below presents the aforementioned directives, regulations, decisions and recommendations by sector and date provided for in a transition period, which commenced on 1 September 2014, when a large part of the Association Agreement entered into force provisionally.¹

The presented information provides a basis on which to identify the parliamentary committees that, in coordination with the Committee on European Integration, will engage in the process of the approximation of Georgian legislation with that of the EU during 2019-2020. These identified parliamentary committees are as follows:

- ✓ **Agrarian Issues Committee**
- ✓ **Human Rights and Civil Integration Committee**
- ✓ **Education, Science and Culture Committee**
- ✓ **Environmental Protection and Natural Resources Committee**
- ✓ **Sector Economy and Economic Policy Committee**
- ✓ **Legal Issues Committee**
- ✓ **Budget and Finance Committee**
- ✓ **Healthcare and Social Issues Committee**

The Association Agreement has been valid since 1 September 2014, and the Parliament and the relevant parliamentary committees have already undertaken the implementation process. The tables presented above show that their activity is likely to increase as the implementation period continues. A baseline study (2017) showed that it was mostly lawyers, economists and international relations specialists who were employed in the staff of the relevant committees. However, none of

those employed were specialists in EU law, including in the Legal Issues Committee. Moreover, it is essential that the English-language skills of the committees' staff employees are improved, given that the legal acts related to the Association Agreement are not translated fully into Georgian by the Legislative Herald. The lack of such language skills may lead to some delays in the retrieval of information, research and the law-making process. None of the employees in any of the committees had been assigned to work exclusively on the implementation of the Association Agreement. Some of the employees of the Committees have attended a donor-funded training on the issues of legislative approximation and/or regulatory impact analysis, however the general level of knowledge of these subjects among staff remains scarce.

Considering all the above, it is important to strengthen the human resources of the Parliament to ensure the timely and effective implementation of the presented action plan.

2019-2020 ACTION PLAN OF THE PARLIAMENT OF GEORGIA FOR THE IMPLEMENTATION OF THE ASSOCIATION AGREEMENT

The presented action plan defines strategic goals in three main areas:

1. Law-making activities of the Parliament, related to the implementation of the Association Agreement;
2. Oversight of the Association Agreement implementation process; and
3. Informing citizens about the Association Agreement and EU integration process.

This action plan defines certain activities that will enable these strategic goals to be reached. The action plan includes performance indicators that will allow for an assessment of the quality of performance of each activity. The presented document will assist the Parliament to better conduct its activities in the implementation of the Association Agreement, ensuring the involvement of civil society, experts and other interested groups in this process and providing information to the population about the process of Georgia's approximation with the EU.

COMMUNICATION STRATEGY AND ACTION PLAN OF THE PARLIAMENT OF GEORGIA ON EU INTEGRATION

COMMUNICATION STRATEGY

The Communication Strategy of the Parliament of Georgia on EU integration (hereinafter, referred to as the Communication Strategy) includes the following key components:

- ✓ Communication vision
- ✓ Communication mission
- ✓ Strategic goals and objectives
- ✓ Target audience and messages
- ✓ Communication tools
- ✓ Communication management

Communication vision

The vision of the Communication Strategy defines the main objective of the implementation of the action plan. It also outlines the status that the Parliament should achieve, from the perspectives of both internal and external audiences, by the final stage of the strategy. Thus, the vision was officially formulated as follows:

By 2020, the Parliament of Georgia should represent an active link in the communication of issues of EU integration, should demonstrate positive changes, and should create an agenda within the information space for the issues related to EU integration.

Communication mission

The communication mission defines the main function to be fulfilled by the Parliament of Georgia in the information space during activities and communication with various groups on issues relating to EU integration. Accordingly, the following definition of the mission has been provided:

In line with its own functions, the communication mission of the Parliament of Georgia on the issues of EU integration is to raise the awareness of a wide audience encompassing different target groups and to unite the efforts of various stakeholders or involved parties to communicate positively to obtain a high level of support among society towards the process.

Strategic goals and objectives

The following strategic goals were defined to achieve the presented vision, as well as for purposes of communication support for the Parliament on European integration issues:

1. Raising awareness about EU integration process and its outcomes
2. Refinement and improvement of communication process management on EU integration issues

Target audience and messages

For effective implementation of the communication and public relations processes of the Parliament on EU integration issues, it is important that communication is targeted. This will focus on informing, educating and engaging with specific groups. This will, on the one hand, allow for the optimal use of resources and, on the other hand, encourage social discussion and conversations. Therefore, information will be kept up-to-date and reliable.

Communication tools

It is important to educate the media regarding the EU integration process, which will have long-term and permanent consequences, to ensure correct and deep coverage. The focus should be on the engagement of representatives of national and regional media outlets in various types of educational and informational activities that will provide them with more detailed information about the benefits of the EU integration process. In this regard, it is necessary that the Committee on European Integration conducts informational meetings with media representatives on a regular basis on selected/actual issues of the European agenda. Furthermore, besides media-tours and seminars, it would be beneficial to involve journalists and other representatives of the media in the decision-making processes. Communication campaigns and similar activities should also be planned.

In the Georgian information space, false stereotypes about EU integration are particularly rife. This problem cannot be solved by unilateral communication, regardless of how reasonable and convincing the argument may be. Indeed, the audience's reception is limited if it does not participate itself in a variety of discussions and is not allowed to develop its own opinion related to certain issues. Thus, the initiation of public discussion is important to give prominence to the most important (acute) issues, and to provoke the thinking of members of different target groups. This should be carried out through social media networks and various media outlets. Clearly, the internet and local opinion leaders will play key roles in this process.

Carrying out campaigns

To ensure effective communication about EU integration issues, it is important to use the so-called "campaign approach." This is particularly helpful when adopting a new legislative amendment or when introducing a new regulation. Ultimately, it is important that such campaigning significantly improves the public processes and contributes to the fulfillment of the obligations of the Association Agreement. For this purpose, the identification of a specific issue, branding, elaboration of a specific activities' plan, and the implementation of such activities under a single umbrella is necessary. Doing so increases the likelihood, in the overloaded information space, of the population perceiving and remembering key messages.

In this regard, it is important to carry out specific campaigns on topics and issues such as environmental protection/waste management, protection of labor rights, food and toy safety. During the campaigning, intensive direct communications, especially in the regions, will be important.

Communication management

Based on the present strategy, a long-term action plan has been prepared, and the Committee on European Integration shall be responsible for its implementation. However, the existing resources for the implementation of this strategy and action plan are not sufficient. Therefore, in the process of the implementation of the strategy by the Committee on European Integration, the capabilities and the efforts of different committees, as well as relevant structural entities (such as the Department of Public Relations and Information), must be unified.

To ensure better implementation of regional activities, the Parliament may use local bureaus of majoritarian MPs as a resource center for communications on EU integration and as a coordination link for activities to be conducted locally. For this purpose, the representatives of the bureaus must be trained and provided with special information materials and message-boxes. The employees of the bureaus of the majoritarian MPs may be trained together with the representatives of local self-governments.

Assessment reporting procedure

Regular monitoring and reporting of the Communication Strategy and Action Plan of the Parliament of Georgia on EU Integration is important. Every six months, a detailed report on the implementation of the action plan shall be prepared including the following information:

- ✓ Activities planned for the given period;
- ✓ Details of what was done and how over a given period;
- ✓ Reasons behind any activities failing to be accomplished;
- ✓ Recommendations for amendments to be made to adequately fulfill the plan and to neutralize any hindrances; and
- ✓ Any changes needing to be made to the plan.

Based on the contents of this report, if necessary, changes should be made both to the strategy and the action plan.

An assessment of the effectiveness of the realization of the communication strategy and tasks that should be carried out are outlined below:
