
MAP OF MUNICIPALITY

The municipality has 26 schools with up to 1,000 students attending



THE NUMBER OF FARMS AND SECTORAL DIVERSITY IS INCREASING:


- Viticulture is prominent (Tsolikauri; Tvishi; Usakhelauri; Ojaleshi; Khvanchkara, etc.);
- Social fruit varieties (grapes, persimmons etc.) have a special taste and long shelf life;
- An abundance of corn and beans grown across 400 hectares;
- Excellent conditions for apiary production;
- Mountain rivers create favorable conditions for the development of fisheries;
- Every Livestock farming is a traditional and dominant sector:
- Pastureland accounts for 76% of the total area of the municipality and the sector has high potential for growth and future investments.




LAND ASSETS AND POTENTIAL FOR USE

Untapped agricultural resources: 18% of the total land area (75,540 ha) is for agricultural use; 70% of agricultural land is still government-owned; Main crops - corn, beans, grapes; and Pastures represent a significant part of the agricultural land.

MAJOR PROJECTS (ONGOING AND PLANNED)

Development of road infrastructure and utilities management:

- Access paths to Sairme Stone columns are under construction
- Road between Chkum and Kulbak is under rehabilitation
- Landscaping of the areas around the temples is underway





TOURISM POTENTIAL IN TSAGERI MUNICIPALITY

The municipality is rich in tourism facilities, natural attractions, and religious monuments including:

Tomb of St. Maximus the Confessor:

Sairme stone columns;

80-meter high Ghvirishi waterfall; and

Muri Fortress.

"Green Lake" - Space for picnics and amateur fishing;

- "Open Air" Museum dating back to the VI century and fortress remains:
- Khvamli Mountain and Ancient Church; and

Potential for the development of religious tourism.

BUSINESS-ENABLING ENVIRONMENT

- State and local laws promote investment activities;
- Simple and efficient procedures for obtaining licenses and permits;
- Convenient conditions for property registration and management; and
- Various business services available in one place under the 'one-window' principle.

LOW AND EFFICIENT TAXATION CONDUCIVE TO BUSINESS

- ✓ Corporate Profit Tax of 0% or 15% encourages reinvestment;
- ✓ Personal Income Tax 20%;
- ✓ VAT 18%;
- Property Tax 1%;
- ✓ Customs/Import Tax 0%, 5%, or 12%;
- ✓ Personal Income Tax on Interest, Dividends, Royalties 5%
- Pension Contribution 6% (2% paid by Employer, 2% paid by Employee, 2% paid by Government); and
- ✓ Double taxation avoidance treaties with 55 countries.

ADVANTAGES OF DOING BUSINESS IN HIGH MOUNTAINOUS SETTLEMENTS

- All the settlements in Tsageri municipality have been granted the status of high mountainous settlements according to the Law of Georgia on the Development of High Mountainous Regions.
- Therefore, business entities registered in Tsageri Municipality have tax privileges stipulated by the Law.

Business entities which, in accordance with the legislation of Georgia, have been granted the status of a high mountainous settlement enterprise have tax relief from Corporate Profit Tax, Personal Income Tax, and Property Tax.

REAL ESTATE MARKET

- Low land prices compared to the national average;
- Relatively low costs to start and operate a business;
- Price per square meter of non-agricultural land 3-6 GEL; agricultural land 2-3 GEL;
- ✓ Possible to buy a typical two-storey house for 10,000-20,000 GEL; and
- ✓ Opportunities to rent warehouses or office space for 3-5 GEL/m².

GOVERNMENT SERVICES FOR BUSINESSES

- Tsageri Community Center provides public services;
- Community center in the village of Lajana also offers public services;
- Public Registry possible to buy and sell real estate, receive other business-related services and access land registry;
- Branch of National Archives;
- Tourism Information Center.



STATE SUPPORT AND SUCCESSFUL INVESTMENTS

INTEREST FROM THE PRIVATE SECTOR IS INCREASING

- Area of cultivated vineyards is growing;
- Milk and dairy processing enterprise, Cooperative "Chrela," was established in 2018;
- Tourism facility "Green Lake" opened in the village of Kulbak in 2007; and
- Gveso livestock farm and goat cheese processing plant put into operation in 2019.

GOVERNMENT SUPPORTS BUSINESS ACTIVITIES

- Encourages family hotels, wine and organic food production, sustainable use of mineral water resources, arrangement of camps, renovation of wine cellars, etc.; and




