#### **India wins 2013 UN Public Service Awards in 3 categories**

UN Public Service Awards are given every year in recognition of excellence in public service. It rewards the creative achievements and contributions of public service institutions that lead to a more effective and responsive public administration in countries worldwide. Through an annual competition, the UN Public Service Awards promotes the role, professionalism and visibility of public service. This year India won awards in the following 3 categories:

- Category 1: Preventing and Combating Corruption in the Public Service
   1st Prize: Chief Minister's Office Mass Contact Programme (MCP)
- Category 2: Improving the Delivery of Public Services
  - 2nd Position: District Administration, Dhanbad, SWAVALAMBAN
- Category 5: Promoting Gender-Responsive Delivery of Public Services
  - 2<sup>nd</sup> Position: **Department of Cottage and Rural Industries, GRAAMIN HAAT**

## **Panchayat elections in Punjab**

As many as 13,080 panchayats in Punjab will go to polls on July 3. The Punjab government in its delimitation exercise has created 81,412 wards in the state. The election commission has made arrangements for keeping two ballot boxes at every polling booth, one for the election of the sarpanch and the other for the panch. The government has also made an amendment in the Punjab Panchayati Raj Act to hold direct elections to sarpanches this time. Meanwhile the Punjab government has also announced a cash prize of Rs. 1 lakh for panchayats elected unopposed. Read more here

## Karnataka urged to stop changes in Panchayat Raj Bill

The Grama Panchayat Hakkottaya Andolana has urged the state assembly that the Karnataka Panchayat Raj (Amendment) Bill, 2013. The bill calls for disqualification or removal of the president concerned or a member by the regional commissioner for not holding two successive meetings as proposed. Hailing these as unconstitutional and totally unacceptable, the body added that this bill clearly means to usurp the powers of the grama panchayats whose presidents and members include women representatives and representatives from marginalised communities who presently face many real challenges in performing their duties, including holding meaningful ward and grama sabhas.

# UNDP Global calls for inclusion of leaders of local governments in decision making in post-2015 framework: Geraldine Fraser-Moleketi, Head UNDP Democratic Governance Unit

At a recent meeting on Decentralization and Local Governance (DeLoG), Geraldine Fraser-Moleketi challenged development partners to go beyond advocating for local governments and to take more concrete actions to integrate them into decision-making processes. She also encouraged them to improve their methodologies for facilitating governance at the local level, particularly in post-conflict and fragile situations. The three-day event – where the United Nations (UNDP, UNCDF, and UN-Habitat) hosted representatives of 27 multilateral and bilateral organizations on effective multi-level governance – was

also an opportunity to assess potential entry points for integrating local governments in the Post-2015 Framework, including recognizing urban-rural linkages and synergies.

These women Gram Pradhans were those who had dropped out of the first phase of the raining so that continuity is maintained with both phases of training. The objective of the exercise was to mobilize Women Pradhan for second phase training, and ensure their participation. Under this exercise Women Pradhan individually contacted and briefed about the first phase training topics and learning. Through the exercise 100 Women Pradhan from three districts Jaunpur, Mirzapur and Sonebhadra were covered. Relatives of Women Pradhan also participated in the Mop- up session.

The Committee was formed with the following objectives:

- a) To review the existing policy and guidelines of relevant Centrally Sponsored Schemes dealing with social sector/anti-poverty programmes and to give specific recommendations: i) for an appropriate role and responsibility of Panchayats at different levels based on the principle of Panchayats at different levels based on the principle of subsidiarity, ii) for strengthening their capacity to deliver services and iii) for making them accountable to respective Gram Sabhas.
- b) To flag the constraints that may come up in operationalizing the delivery system through the PRIs and suggest ways and means of dealing with the same.
- c) To suggest ways to incentivize States to devolve three Fs i.e Funds, Functions and Functionaries to Panchayats.

# **First-ever global survey on participatory local democracy** (From John Coonrod, The Hunger Project)

The first-ever global survey of participatory local democracy is entering its final weeks, and requests your participation. The two-part survey (statutes and perceptions), first developed at a consultation last January at Institute of Social Sciences (ISS) New Delhi, will produce a multidimensional Participatory Democracy Index. To date, more than 500 practitioners from 64 countries have taken the 15-minute survey. Results will be published in September 2013 at the opening of the UN General Assembly.
