Parliament passes the Land Acquisition, Rehabilitation and Resettlement Bill

The Bill was passed by both Houses of the Parliament in the monsoon session. The bill aims to provide fair compensation to those whose land is taken away; brings transparency to the process of acquisition of land to set up factories or buildings and assures rehabilitation of those affected. Parliament approves Food Security Bill

Parliamentary approval was accorded to the landmark Food Security Bill. This bill gives right to subsidized grains to 800 million people and is the largest such scheme anywhere in the world. Under the legislation, beneficiaries would get five kg of grain per person per month which would include rice at Rs.3 per kg, wheat at Rs.2 per kg and coarse grains at Re 1 per kg. Marriage Laws (Amendment) Bill, 2010 finally gets the nod of the Rajya Sabha

Rajya Sabha passed the Marriage Laws (Amendment) Bill, 2010 on September 5th 2013, to amend marriage laws that seek to provide for irretrievable breakdown of marriage as a ground for divorce with safeguards to the wife and children. The Bill aims to make divorce friendly for women providing for the wife's share in the husband's immovable property after "irretrievable breakdown" of marriage. Read the text of the bill here

Lok Sabha passes long-pending Pension Bill

The Lok Sabha passed the Pension Fund Regulatory and Development Authority (PFRDA) Bill 2011. The Bill allows 26% foreign investment in the pension sector and gives statutory backing to the interim pension authority that had been functioning on executive authority for over a decade now. It also gives legal backing to the pension regulators to create a social security architecture that channelize savings of households into the financial sector.

Delhi Human Development Report 2013 released (From Resource Team, UNDP, New Delhi)



Does Not India Need a Default Option in the New Pension System?

This paper, brings out the many shortcomings of the New Pension System in India, examines the need to include the default option in the scheme. The default option is a necessity to make the defined contribution (dc) system more acceptable and successful. A number of countries have this option but not India. A model portfolio is also proposed.

• National Pension Scheme: For Whose Benefit?

Pension reforms in India in the last decade have seen three major initiatives - a paradigmatic shift in the civil servants' pension scheme, the National Pension Scheme for all citizens and the New Pension System Lite for the economically disadvantaged sections with small savings. An analysis of the auto choice option under the NaPS and the demographic transition reveals potential future imbalances in the investment structure among the asset classes. Moreover, the NaPS does not even guarantee a minimum pension, thus defeating its "welfare" orientation.

Ballooning Current Account Deficit: What Options? By Ajit K Ghose

The article discussed the reasons for the current fall in rupee value against the dollar and what are the probable options available with the government to improve the situation.

Excerpt: The choice before the government in dealing with the widening current account deficit is not between good and evil but between the two evils of attracting foreign capital and imposing curbs on imports. If the government chooses to focus on attracting foreign capital rather than on curbing the merchandise trade deficit, it is implicitly making a judgment that the risk of economic collapse tomorrow is to be preferred to the risk of higher inflation (and perhaps lower growth) today. This judgment can and must be questioned.
