Delegates from 22 countries of Africa and Latin America will witness the world's largest democratic exercise in April-May when an over 800-million strong electorate, the world's largest, votes for India's new government. This will be facilitated under the Election Commission and United Nations Development Programme (UNDP) project titled Supporting Democratic Electoral Management. Commencing this April, the new Companies Act, 2013, will require a certain class of companies to mandatorily spend on corporate social responsibility (CSR) initiatives. The statutory provision under Section 135 of the Act mandates every company having net worth of Rs. 500 crore or more, or turnover of Rs. 1,000 crore or more, or net profit of Rs. 5 crore or more to spend in every financial year at least two per cent of the average net profits made during three immediately preceding financial years. #### Missing half the demographic dividend

According to estimates by the World Bank, the working-age population (15 to 59 years) is set to increase by more than 200 million in India over the next two decades, while it is expected to decline in most developed regions of the world, even China. However, India might fail to reap the benefits, mainly on account of the extremely low rates of female participation in the country's economy. The proportion of females (aged 15 years and above) in the labour force in India in 2012 was only 29 per cent compared to 64 per cent in China.
