We are happy to share the 86<sup>th</sup> Update on Decentralization Community of Practice!

This update comes to you with news on Prime Minister Shri Narendra Modi launching 5 new schemes: **Shram Suvidha Portal, Random Inspection Scheme, Universal Account Number, Apprentice Protsahan Yojana, Revamped Rashtriya Swasthya Bima Yojana.**

Additionally we are sharing information on: Gram Panchayat bringing grass-root development in Manipur; release of Rs. 800 crore by government of Andhra Pradesh for gram panchayat's development; recommendation of formation of additional 439 Gram Panchayats in Karnataka by S G Nanjaiahmath committee; launch of scheme named **Vanbandhu Kalyan Yojana (VKY)** in 10 states to lift human development indices of tribal people; setting up of **5<sup>th</sup> Finance Commission by Himachal Pradesh** and Kudumbasree to promote women agripreneurs.

#### Gram Panchayat bring grass-root development in Manipur

Yumnam Khunou village in Imphal East is witnessing a boom with the implementation of various government-run schemes by the Panchayat. The people are also happy with the change. A lot of development work related to water supply, pond and irrigation facility has been done by the Gram Panchayat in the village. Read More [here](#)

#### AP to release Rs 800 crore for gram panchayat's development

Andhra Pradesh government has ordered for release of Rs 800 crore for Gram Panchayats to facilitate development of infrastructure particularly for laying roads, drainage system, installing street lights and ensuring health and sanitation. This was following a review of the financial utilization of resources of 26 departments. Read more [here](#)

#### Committee recommends formation of 439 Gram Panchayats in Karnataka

The S G Nanjaiahmath committee, which was set up by the Rural Development and Panchayat Raj department, Government of Karnataka, has submitted its report, seeking creation of 439 new Gram Panchayats (GPs). The Gram Panchayat Restructuring Committee, which was formed in March this year, travelled across the 30 districts to receive applications and listen to the grievances of people over various administrative issues plaguing GPs in the State. The committee has suggested one GP for every 5,000 to 7,000 people. Read more [here](#).

#### Prime Minister Inaugurates Shramev Jayate and 4 other schemes

Prime Minister, Shri Narendra Modi has launched the following new schemes:

- A dedicated **Shram Suvidha Portal**: Under this, Labour Identification Number (LIN) will be allotted to nearly 6 lakhs units and allow them to file online compliance for 16 out of 44 labour laws;
- An all-new **Random Inspection Scheme**: Utilizing technology to eliminate human discretion in selection of units for Inspection, and uploading of Inspection Reports within 72 hours of inspection has been made mandatory;
- **Universal Account Number**: Enables 4.17 crore employees to have their Provident Fund account portable, hassle-free and universally accessible;
- **Apprentice Protsahan Yojana**: Will support manufacturing units mainly and other establishments by reimbursing 50% of the stipend paid to apprentices during first two years of their training;
- **Revamped Rashtriya Swasthya Bima Yojana**: Introducing a Smart Card for the workers in the unorganized sector seeded with details of two more social security schemes.

#### Scheme to lift human development indices of tribal people launched

Union Tribal Welfare Minister Jual Oram launched the Vanbandhu Kalyan Yojana (VKY), aimed at improving the infrastructure and human development indices of the tribal population. The scheme is being piloted in Odisha, Jharkhand, Chhattisgarh, Andhra Pradesh, Madhya Pradesh, Himachal

Pradesh, Telangana, Rajasthan, Gujarat and Maharashtra. The VKY will focus on convergence of different Central and State schemes of development with an outcome-oriented approach.

### **Himachal Pradesh sets up 5<sup>th</sup> Finance Commission**

Himachal cabinet will set up its fifth state finance commission to give its recommendations for next five years from April 1, 2017 onwards. The commission which would consist of a Chairman and two Members would have same terms of reference as of Fourth Finance commission and would submit its report by April 30, 2016. One of the key areas of reform and recommendations will be panchayat and municipal finances. Read more [here](#)

### **Gram Panchayats Roped in to Abolish Child Labour in Odisha**

With unending migration throwing up serious instances of exploitation of child labourers in the State, the Odisha Government has developed a **Common Action Plan** for Elimination of Child Labour through strengthening of enforcement mechanism, greater awareness generation, education and skill development training to the vulnerable as well as rescued children, their rehabilitation and a monitoring mechanism. For this, gram panchayats (GPs), panchayat samitis, zilla parishads and district administration would be actively involved in prohibition, registration and rehabilitation activities. Additionally, GPs will be asked to identify the vulnerable families so that they could be brought under the fold of income generating schemes and programmes. Similarly, the sensitisation programmes will be intensified at village, panchayat and urban local bodies (ULBs).

### **Kudumbasree to promote women agripreneurs**

With a view to promote women *agripreneurs*, Kudumbasree has embarked on a programme providing specialised training for a select group of women in mechanised agricultural practices. The objective is to propagate farm mechanisation at local-levels and thereby equip women to take up women-focused development projects in farm sector, focusing on less manual labour, more profit, improved health and more leisure time, these women farmers will be able to make use of women friendly agro machineries and reap benefits.

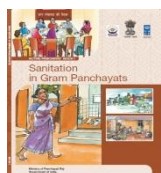

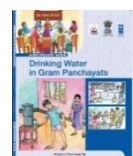
### **Active Panchayat Series: Publications**

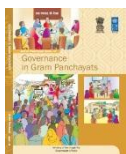
#### **Drinking Water in Gram Panchayats**
