➤ **QUERY: Role of PRIs in improving the health and nutritional services at village level. Experiences and Advice**

Most of the Central and State Government programmes are supposed to be implemented through panchayats at the village level. Since the upper castes are socially, culturally and economically powerful, they hold key positions in the village, which gives them the power to take decisions or influence the selection of beneficiaries under the government programmes. This prevents the selection of beneficiaries from SC and ST community for most of the beneficiary oriented schemes and also does not allow them from assessing the services, though most of the development programmes are meant for them.

Members of the decentralization community are requested to share their experience and examples on:

- What role can PRIs /Village Health, Sanitation & Nutrition Committees play in bridging the gap between the existing healthcare providers and the people in need of services particularly the excluded groups during Village Health, Sanitation & Nutrition (VHSN) days ?
- What are the parameters that need to be included while assessing the quality of the Health & Nutritional services of a village?
- What are the ways to assess/ investigate the access of services (Information, Physical, Financial and Social Capital) by the excluded community in a village

➤ **Drafting Public Interest Litigation for Effective Devolution of Powers to Panchayats. Advice and Examples**

Panchayats are meant to be autonomous institutions of self-government however they are treated as subordinate authorities at present. There is a wide variation in the devolution of powers to the panchayats across states. Further power, authority and responsibilities of Panchayats as envisaged in the Article 243G could not be exercised, as the State Governments were unable to empower them to collect taxes under Article 243H and Finance Commissions were formed under Article 243-I to initiate measures to improve financial position of Panchayats. Hence panchayats are not in a position to undertake the responsibilities in respect of items stated in Schedule XI of the Constitution. Also various Centrally Sponsored Schemes (CSS), which are under the purview of Panchayats, are being directly implemented in a mission mode approach. There is a need for reviewing CSS to enable State Governments to devolve power and functions to PRIs. Such review can be enforced through Public Interest Litigation (PIL) to the Supreme Court highlighting the above issues. Members are requested to comment and share their insights on:

- Whether it is necessary to seek time bound directions from Supreme Court to the State Governments to implement the 73<sup>rd</sup> Constitutional amendment?
- What are the administrative advantages /disadvantages of implementing CSS through Societies instead of departments of state governments or through Panchayats?
- How many states have constituted Finance Commissions under article 243I? Are the findings of the State Finance Commissions constituted so far, available in the public domain under article-4 of RTI Act?

**439 new gram panchayats to be established in Karnataka**

Karnataka state cabinet has taken a decision to constitute 439 new gram panchayats taking the total panchayats to 6068 in the state. Under this there will be a gram panchayat for every 7-8 kms radius.

An additional Rs.69 crore has also been approved for their creation. The delimitation exercise was carried by a committee headed by S G Nanjayanamath.

### **Panchayats in Haryana to be rewarded for water conservation**

The district authorities in Sirsa, Haryana have announced that village panchayats that work towards conservation of drinking water will be given cash reward between Rs 20,000 to Rs 50,000 depending upon the population. Villagers are encouraged to set up recharge pits so that the water flowing in the streets did not go waste. District authorities have also issued a toll free number 1800-180-5678 for lodging any kind of complaints regarding supply of potable water.

### **Wi-Fi hotspots in Kerala panchayats soon**

Bharat Broadband Network Limited (BBNL), a special purpose vehicle set up by the central government for the establishment, management and operations of National Optical Fiber Network project (NOFN), has started working on establishing Wi-Fi hotspots in grama panchayats in Kerala. This will enable delivery of various services such as local planning, management, monitoring and payments under government schemes at panchayat level. The project is modelled on the NBN project, which is being implemented in Australia.

### **Government to involve private players to cover 50 thousand panchayats under NOFN**

To expedite roll out of National Optical Fibre Network (NOFN) for high speed broadband in rural areas, the government will float tender in March to invite private firms for laying fibres across 50 thousand village panchayats. The government has set target to complete the roll out of NOFN across 2.5 lakh village panchayats by December 2016. The network aims to deliver broadband connections of 100 megabit per second download speed at village panchayat level. Bharat Broadband Network Ltd is currently handling roll out of NOFN through three public sector firms -BSNL, RailTel and PowerGrid.

### **Panchayats in Telangana to collect tax online**

All the village panchayats in Telangana will soon have computers for online tax payment. The government will install around 2,400 computers in the first phase and 2,900 computers in the second phase in the villages. This will boost tax collections by panchayats and panchayats collecting 100 per cent tax will be given development funds from the state government. Under this scheme, each village will have one village-level entrepreneur (VLE).

### **Telangana plans to overhaul gram panchayats**

The Telangana government is contemplating radical changes in the functioning of gram panchayats by bringing in a new legislation to strengthen the system and decentralise power. The gram panchayats would be linked with 29 officials working at village level for proper utilisation of government funds and taxes collected from people. The employees would be made accountable to gram panchayats led by sarpanches in discharging their duties.

### **Government to provide tablets to Gram Panchayats under MGNREGA**

To improving implementation of MGNREGA and enable access to real-time data at the village level, government has decided to implement the first phase of mobile monitoring system from April 1 in 35,000 gram panchayats. Under this Rural Development Ministry will distribute tablets to each of the gram panchayats.

### **Panchayats preparing Community plan**

The Kozhikode district panchayat authorities in Kerala have directed the grama pachayats to prepare community plans at the time of preparing annual projects for the financial year 2015-2016. The community plan will cover details about the grama panchayat bodies, its wards, population,

occupancy, its existing status, major problems and development plans for future. The annual plans shall be prepared on the basis of the community plans.

### **Panchayat Union demands power to Zilla and Village Panchayats**

The Goa Panchayat Raj Institutions Union has called for devolution of powers to the Panchayat Raj institutions in the State and restoration of the executive powers of sarpanch. Earlier the second Finance Commission has made suitable recommendations for devolution of funds to the PRIs, as the village panchayats are starved of funds and are unable to do even the bare minimum to mitigate the hardships faced by the villagers.

### **Government plans to give Rs.10,000 to every gram panchayat for road safety**

To curtail the growing number of road accidents and fatalities in Rajasthan, the state government will provide an assistance of Rs 10,000 to each 9,900 gram panchayats to launch awareness campaigns. The year 2015 is marked as 'road safety year' which aims to bring down the road accidents. The approved scheme will be launched after panchayat polls.

### **Over a billion live on less than \$1.25 a day: Oxfam**

According to a report by Oxfam released on the eve of the Global Economic Forum, if wealth concentration grows at the present rate, in two years 1 per cent of the global population will earn more than the remaining 99 per cent. Global wealth inequality has reached staggering proportions with 1 in 9 people not getting enough to eat and over a billion on less than \$ 1.25 a day. The international agency has called for governments to adopt a 7-point programme to address the problem of staggering inequality.

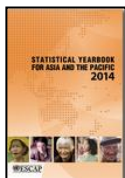
