Ongoing Query

Role of local governments in addressing the problems of transgenders. Example and Experiences. From Jacob John, Kerala Development Society (KDS), New Delhi

Transgender (TG) is a person who chooses to identify himself/herself with a gender different from the one at birth (biologically). The members of the transgender community are treated differently in our society. The incidences of harassment, violence and sexual assault in public places, has led to the violation of human rights and discrimination in the field of education, employment, health-care, voting and contesting elections.

There have been efforts to bring TGs to the mainstream of development in our country. The Supreme Court of India passed a landmark judgment granting constitutional recognition to transgender as the "third gender", on 15th April 2014.

To improve the situation of transgender in our country and to bring them to the mainstream development, National Human Rights Commission (NHRC) has assigned a research study to Kerala Development Society (KDS), Delhi. The study will cover the profile of transgender as a third gender encompassing important socio-economic variables. To strengthen the study, we seek inputs from members of the decentralization community on the followings:

- What are the various entitlements given to transgender community by Union and State governments at different levels in sectors such as education, health, employment, food, pension and in economic activities for self-reliance?
- What are the problems faced by them in accessing the entitlements, given at present?
- What steps can the Local Self Governments (Municipality and Panchayati Raj Institutions) take to address the human rights violation of transgenders?
- Suggest capacity building programmes to improve the skills of transgenders for employment opportunities.

In addition to the above, we request Members to share national and international good practices addressing human rights violation of TGs.

Members' contribution will feed into the study and inputs will be duly acknowledged in the document.

> Strategies for Systematic Voters Education and Electoral Participation (SVEEP).

Advice, Example by Padma Angmo, Deputy Secretary, Election Commission of India and Sumeeta Banerji, United Nations Development Programme, New Delhi

The <u>Systematic Voter Education and Electoral Participation (SVEEP)</u> campaign by the Election Commission of India (ECI) was launched in 2009 with the objective of enhancing Electoral Participation in the country and building a culture of participative democracy.

SVEEP campaign played a key role in ensuring for the first time a record voter turnout of 66.4 percent in India's historic 2014 general elections. The women voters outnumbered men in many states, reducing the gender gap to 1.55 % as against more than 4 % in 2009. In 16 States/Union Territories, women voter turnout was higher than men and women voters surpassed men for the first time ever in nine States/Union Territories.

However, in spite of the above efforts by the Election Commission, nearly 275 million registered voters (33.6 percent) did not participate in voting in the 2014 general election. The Election Commission is presently attempting to identify gaps and improve voter participation.

In order to further strengthen its voter education and electoral participation strategy, the Election Commission of India seeks inputs from members on the following:

- What are the groups that may have been left out and need to be targeted?
- What are the strategies to reach out to the above focus groups and also new strategies to reach out to the groups that have been left out to enhance enrolment and participation in elections?
- In what ways, can the Election Commission reach out to relevant CSOs, opinion leaders, educational institutions, youth/student volunteer networks and other formal and informal groups to strengthen voter awareness and participation?
- What are the effective grassroots level good practices/ innovative measures of community mobilization that can be adopted by Election Commission?

The inputs from members will help the Election Commission of India in framing its voter education and electoral participation strategy to reach out to different target groups.

World misses MDG goal of reducing hunger by half

The world has missed its target of reducing hunger by half since 1990, according to the biennial report released by Food and Agriculture Organization (FAO). According to the report, Indian and Pakistan registered an increasing trend in hunger whereas Nepal, Bangladesh and Sri Lanka registered only a minuscule decline. There were 1.1 billion undernourished people in the world between 1990 and 1992 when the UN Millennium Development Goals were set. It has now come down to below 795 million.

8 Indian states = 25 African nations: Oxford study on poverty

According to new analysis using a unique index developed at the University of Oxford, there are 1.6 billion people living in multidimensional poverty across the world and nearly 440 million of them are in eight large Indian states. The eight Indian states that have similar number of poor as in 25 African countries are Bihar, Jharkhand, Madhya Pradesh, Uttar Pradesh, Chhattisgarh, Odisha, Rajasthan and West Bengal.

Rajasthan forms Finance Commission for Panchayats

Rajasthan Government has constituted the State Finance Commission to review the financial position of Panchayati Raj Institutions (PRIs) and to make recommendations for their improvement. The commission will be headed by Jyoti Kiran and will submit its report by 30 November this year.

Karnataka Government planning to amend panchayat raj Act

It is felt that Taluka panchayat bodies are losing significance as compared to gram and zilla panchayats under the Panchayati Raj System in Karnataka. To strengthen the Taluka Panchayats the government is bringing an amendment in panchayat raj Act. A committee constituted under the chairmanship of Mr. Ramesh Kumar (MLA) has already submitted its report to the state government.

Panchayat's riches-to-needy story

Taking advantage of a clause in the Panchayati Raj Act that allowed it to collect a fee for providing facilities like water, sanitation and lighting at a public resort, the Shatainya gram panchayat in Theog block of Shimla district had developed a park at the Mahasu peak area in Kufri and created facilities for tourists, including toilets. In 2012-13, the panchayat generated a revenue of Rs.39,000 from a single source in a single day.

Digital Punjab puts 13040 panchayats on web

Punjab has become an e-panchayat first state to put data of all its 13,040 village panchayats on its official website (www.pbrdp.gov.in). The functioning of Gram Panchayats in the state has been strengthened through computerisation under e-panchayats scheme and PRIA- soft, a unique software of National e-gram panchayats programme.

Panchayat bhawans to display gender ratio in Hamirpur district in Himachal Pradesh

With a view to reversing the trend of declining child sex ratio in Una district, the administration has decided to put up 'Guddi-Gudda' scrolls in all 235 panchayat bhawans. The boards will display the number of female and male infants born during the month in the panchayat, with the cumulative annual figures displayed along with it.

Rating Process for Panchayats in Odisha

Gram panchayats in Odisha will now be rated on the parameters of health, sanitation, hygiene and nutrition. They will also compete with each other for `Sustha Panchayat Purashkar' award announced by the Government that includes recognition and financial reward for top performers. The villages would be evaluated on certain indicators related to health, sanitation, nutrition, maternal and child issues and service delivery systems.

Odisha Government to help gram panchayats manage funds

As gram panchayats (GPs) would receive more aid from the state government according to the report of 4th state finance commission, the government has decided to extend technical support to them to chalk out plans. Each GP is expected to receive a minimum grant of Rs 20 lakh to prepare their own plans, focusing on local needs. The Planning and Coordination department in collaboration with United Nations Development Programme has decided to take up five GPs in Sundargarh and Ganjam districts in the first phase to give technical support.

Allocation for 'Minus Panchayats' in Kerala

Government of Kerala will allocate Rs.1 crore for the development of 'minus panchayats' - those having very low own funds. The focus is to turn panchayats into institutions that reach out to the public, and not the other way round.

Bihar Government promises 'panchayat Bhavan' in all panchayats

In an move to strengthen the Panchayati Raj system in the state, the Bihar Government is planning to have a Panchayat Bhawan in all the panchayats where the revenue staff will sit and dispose-off their work. To provide the benefits of government schemes to the villagers, a branch of a nationalised bank will be opened in every panchayat.

Gujarat to make voting compulsory in local polls

The Gujarat government has decided to make voting compulsory in the municipal and panchayat elections later this year. This could be the first instance in the country of mandatory voting in civic elections involving millions of voters.

New bill on transgenders soon

Following Supreme Court's verdict in April 2014 recognizing transgender group as "third category". Union Government has decided to pass a legislation to empower transgenders by recognizing them as a special category. The bill is likely to be tabled in the monsoon session of Parliament. The bill is expected to cover social inclusion, rights and entitlements, skill development and prevention of abuse for transgenders.

Money for rural India from Delhi triples

On the recommendations of the 14th Finance Commission, over the next five years, money to rural local governments (panchayats) will rise nearly three times, from Rs.63,051 crore to Rs.200,292 crore. It points out that while gram panchayats generate 11 percent of revenue, block and district-level panchayats generate 0.4 percent and 1.6 percent respectively.

What villages ignore: water, sanitation, streetlights

The article brings an interesting analysis of the spending by the panchayats. It says that Panchayats (village councils) spend most of their money on roads and bridges (38%), followed by maintenance of panchayat buildings (26%). Not enough is being spent on water supply, sanitation and streetlights.

Basin Management Manual (BMM) for Local Self Government Institutions (from <u>J B Rajan</u>, Kerala Institute of Local Administration, Kerala)

As custodians of natural resources Local Self Government Institutions (LSGIs) have great role to play in their management, sustenance and allocation of resources. But considering the complexity of issues involved the management of our rivers and other water bodies are not an easy task. The BMM is pre curser for an in-depth understanding about the basins and water bodies to LSGIs prior to their attempt to prepare a Basin Management Plan.

Report on Revenue Mobilization by Gram Panchayats in West Bengal: Present Situation and Policy Options (from Debraj Bhattacharya, Institute of Social Sciences, Kolkatta)

The overall objectives of the study were to: To critically review the current performance of the Gram Panchayats (GP) in generating revenue from own sources; Identify the reasons responsible for low

level of revenue generation from different tax and non-tax sources; Identify, if possible, the new sources of revenue for GPs; Suggest various measures, including legislative changes, reform of revenue administration and capacity building activities, for augmenting Own Source Revenue (OSR) of the GPs; Recommend possible means for improvement in OSR generation of GPs. While the report specifically looks at the case of West Bengal, it will be of use to scholars and practitioners working on decentralisation in India/South Asia.

Theoretical Perspective of Decentralisation- Vol. III No 26, New Delhi June 20, 2015 (From <u>Jos Chathukulam</u>, Kerala)

The paper says that Decentralisation in India has been guided by mixed motives. Social justice has been one of the key goals of decentralization in India. Apart from providing representation to the excluded groups, it is seen as a key agency for local economic development through local planning. It argues that contradictory goals have brought ambiguity and a lack of direction in the decentralization process and needs to be investigated.

Inclusive Governance-reaching the Unreached (from <u>B.K.Taimni</u>, IC Centre for Governance, New Delhi)

The article stresses that Inclusive Governance represents the extent to which Governance Institutions provide 'space' to overcome the systematic exclusion of disadvantaged groups seeking to participate in decision making, affecting them. Inclusive Governance encompasses the management of social, political and economic issues for Human Development and represents the issues of rights based approach.

Planning Process Eludes District Plan Panels (From <u>Shamla Edathil</u>, DecWatch Group Member) The article points that people's planning in the Kerala state is 19-year-old but the district planning committees are yet to execute their Constitutional responsibility to prepare district development plans. However in the present system, a DPC's role is confined to approving the plans of panchayats and urban local governments.




