#### From the Resource Team

Dear Members,

The farming community, scientists and governments (Union and States) were worried due to the delay in South West monsoon. But when the rains came, it brought misery to the states of Gujarat and Assam; Mumbai City and Konkan Coast, due to floods and overflowing of rivers and its tributaries. The floods displaced thousands of people in hundreds of villages in Assam and Gujarat; Mumbai City came to stand still for two days (18-19 June 2015). The situation is not new to Mumbai or Assam, year after year the grim situation repeats. But, is there learnings from these situations that we could assess and take necessary short and long term measures to overcome the situations. Most often our learnings are not converted into concrete actions for unknown reasons.

## ISDR Asia Partnership (IAP) meeting 3-5 June, 2015 (Bangkok, Thailand)

International Strategy for Disaster Reduction (UNISDR) held IAP meeting from 3-5 June, 2015 in Bangkok, which was attended by around 90 people from 17 Asian countries and 33 international institutions. The main focus of this IAP was to discuss the way forward from the 3rd World Conference on Disaster Risk Reduction and implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030 (SFDRR) in the Asian Region.

At first, the Secretariat of UNISDR explained the background of this meeting; the 1st Asian Ministerial Conference for Disaster Risk Reduction (AMCDRR) after SFDRR will be hosted by the Government of India in November 2016, and its intended outcome of this AMCDRR in India will be to an 'Asian Regional Implementation Plan of the SFDRR'. Then, the Government of India showed the process of preparation toward the next AMCDRR.

In this meeting, considering the importance of involving the wide-range stakeholders, a session especially devoted to the public private partnership was held and the various participants such as ADPC and Japan Bosai Platform.

OPINION: What next for the Sendai Framework for Disaster Risk Reduction? Perspectives from South Asia.

According to Amy Kirbyshire, SFDRR has been compared favourably to the Hyogo Framework for Action (HFA) on many fronts, including for the enhanced role for science, and recognition of social processes and weak institutional arrangements as drivers of risk. Though, SFDRR clearly isn't perfect, but we do have a new and improved global framework for tackling disaster risk. It is now up to national governments to put these words into action.

Finally, the SFDRR itself places too little emphasis on domestic (compared international) resources and improving national capacity to mobilise those resources. A strong feeling is that the countries in South Asia need to focus on helping themselves, rather than looking first to the international community for finance. 

#### News from across the Country- Floods in Gujarat, Assam and Mumbai

#### **Gujarat**



Western parts of <u>India</u> have been battered by torrential monsoon rainfall over the last 48 hours. The state of <u>Gujarat</u> has felt the brunt of the downpour and the subsequent flooding. Over 200 mm of rain fell in Surat in the last day. The latest reports say that as many as 50 people may have been killed in the flooding in Gujarat, with over 10,000 displaced.

Many of the deaths were caused by collapsing houses. The coastal district of Amreli is said to be one of the worst hit areas. Reports say that over 30 people have died as a result of the heavy rain and floods there. Other districts affected include Rajkot, Gir-Somnath,

#### **Assam**

2 Weeks of Flooding - 72 Villages Still Under Water in Assam, India



According to Assam State Disaster Management Authority (ASDMA), there are currently over 300,000 people in 700 villages across 15 districts in the state are affected by the floods that began with the onset of monsoon rainfall earlier this month. The heavy rain in Assam state and other catchment increased levels of the Brahmaputra River and its tributaries.


Though the flood situation has improved, 72 villages remain flooded in the districts of Barpeta, Dhemaji, Tinsukia, Morigaon and Lakhimpur. CWC report that the Brahmaputra is above

warning level at Badatighat, Dhubri, Dibrugarh, Goalpara, Jorhat and Sonitpur( in Assam, but the current trend is steady rather than rising. (Source: floodlists.com).

#### Mumbai

## <u>Heavy Rain and High Tide Combine to Flood Mumbai – 300 mm of Rain in 24 Hours</u>

Heavy monsoon rain in Mumbai, India, had brought wide areas of the city to a standstill. Roads have been blocked, rail services interrupted and flights delayed. Some power generating plants have been shut down by Mumbai electricity board after flooding was considered to pose a danger. Many schools have also been closed for the day. (19 June 2015. Large stretches of India's West Coast (Mumbai to Cochin) received heavy rain between 18<sup>th</sup> and 19<sup>th</sup> of June 2015. The rainfall figures were; Ratnagiri – 147 mm; Cochin – 96 mm; Mangalore – 52.8 mm and Goa – 108 mm.
