#### From the Resource Team

Dear Members,

The torrential rains in Assam in the second half of August 2015, caused overflowing of Brahmaputra and its tributaries causing floods across 19 districts of Assam and affecting nearly 600 thousand people. The Assam State Disaster Management Authority (ASDMA), Indian Army and NDRF worked round the clock to evacuate people from flooded areas to relief camps and providing relief measures. Due to preparedness efforts of ASDMA, the number of fatalities was limited to 14; Relief operations have reached to most of the affected population. According to the ASDMA report, the losses are indicated only to extent of inundation of agricultural land and its impact on crops. Data on loss of livelihood, especially of traders, industries (SME) and loss to the market is yet to be assessed.

Accounting of loss due to disasters in secondary and tertiary sectors is not well established, due to various factors. In the workshop held on 24th Aug 2015 on "Enhancing Private Sector Partnership for Disaster Risk Reduction", a case study of Thailand floods -2011 was presented, where it showed that losses to the private sector during disasters is around 80% and in case Thailand Floods nearly 30% of SME entrepreneurs had to shut their units after the disaster. This impacted livelihood of the employees and their families. The workshop organised was to bring in the concept of Disaster Risk Reduction and the need for risk sensitive investment planning in business and industries to disasters, so as to enable business continuity operations even after disasters. The workshop flagged number of issues that needs further deliberations and follow-up. Two key issues that were flagged are Risk reduction measures are to be applied for business continuity both at local and national level for reducing supply chain loss and most importantly creating a national database of small and medium enterprises as nearly 70% them don't have enough capacity to access any government incentive to be bailed out after disasters.

On 27<sup>th</sup> August 2015, the cabinet announced 98 SMART Cities for implementation across the country. The purpose of the Smart Cities Mission is to drive economic growth and improve the quality of life of people in Urban areas by enabling local area development and harnessing technologies that leads to Smart outcomes. The identification of smart cities was based on 10 key infrastructure development indicators, the details can be viewed at <http://smartcities.gov.in/writereaddata/SmartCityGuidelines.pdf>. In the smart city mission statement and guidelines there is hardly any mention of Disaster Risk Reduction, rather a passing remark to disasters. Whereas, the suggested infrastructures for Smart Cities are vulnerable to different kinds of hazards and it is very important for Special Project Vehicles to identify DRR components to be mainstreamed into Smart Cities Mission, for the purpose to be accomplished. The economic growth can be sustained only, if the damages to infrastructures during disasters are minimal and if the private business units which hold key to economic growth does not suffer huge losses and damages during disasters.

We thank members for their contribution to the community updates and for their inputs to discussion topic New Education Policy. Look forward for further inputs in strengthening Disaster Management Community of Practice (DM CoP).

United Nation's Volunteers, UNDP and Ministry of Youth Affairs and Sports,

November 2015, in collaboration with Government of Andhra Pradesh and various local, national, regional and international organizations, six years after the First Congress. This would be the largest Congress on disaster management organized by a non-governmental organization. The Congress would deliberate on all possible aspects of disaster risk management in as many as 28 Thematic Sessions, structured around 10 Clusters. The Congress would highlight the need for coordinated research and action involving all stakeholders for holistic management of disasters, in all its cycles - during pre-disaster prevention, mitigation and preparedness; on disaster response and relief; and post-disaster recovery and reconstruction. The Congress would debate on the process of implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030.

**[JNA Report of Assam Floods, 2015:](#)** This report contains the compilation of the JNAR Phase -01 actions in the state of Assam, India in the aftermath of the incessant rains from April 17<sup>th</sup> and the subsequent embankment breaches caused massive floods affecting 19 districts of Assam, affecting around 600 thousand people and 14 fatalities reported, as on 22<sup>nd</sup> August, 2015.

#### **[JNA Report of West Bengal Floods, 2015:](#)**

This report contains the compilation of the JNA –Phase 01 actions in the state of West Bengal, India in the aftermath of the incessant rains in the month of July’2015, Cyclone Komen that hit the State on 30<sup>th</sup> of July’15 and release of huge quantum of water from Damodar Valley causing floods in 236 blocks of 14 districts and this impacted nearly 1.06 crore people. Water logging is reported from North 23 Paraganas as on 27 Aug 2015.

Government of India are initiating a new project titled “Strengthening Nehru Yuva Kendra Sangathan (NYKS) and National Service Scheme (NSS)” to promote youth volunteerism in India. ## News from around the world

### Boat Capsizes killing refugees

At least 105 people have been killed and more than one hundred others are still missing after a boat, reportedly packed with refugees bound for Italy, capsized and sank off the Libyan coast. According to the head of Libya's Red Crescent in Zuwara, 105 bodies have been recovered and nearly 200 others have been rescued.



The UNHCR, the UN Agency for refugees, in a statement, released on Friday, said there were about 500 people on board.

Sources told Al Jazeera that many of the dead had been trapped in the cargo hold when the boat capsized on Thursday.

### Tropical Storm Erika devastates Dominica Island

Flooding and landslides kill at least 20 people and leave more than 50 missing in Dominica (Caribbean Island) after tropical storm Erika whipped the island for more than 5 hours on Wednesday (26<sup>th</sup> Aug 2015), with strong winds and intense rain causing floods and landslides. Hundreds of homes have been destroyed.



"Access by road to these communities is impossible," said the prime minister, Roosevelt Skerrit. These towns "are cut off from the rest of the country". Skerrit appealed for international aid and estimated that damage from the storm could set the country's development back two decades.
