Dear Members,

The Disaster Management Community of Practice (DM CoP), UN Solution Exchange, UNDP-India completed 9 years of Knowledge Collation and Dissemination service on 19 April, 2016. This has been possible due to the support from every stakeholder (Governments, Institutions and Members). In the 9 years (2007-16), the DM CoP has enabled in sharing the best practices, experiences, examples and references among 3250 members by producing 191 Consolidated Replies (Knowledge Products), 141 community updates, Face to Face annual meetings, Knowledge Mela's, sharing research papers, jobs and conference announcements, Round Table meetings, Action groups and Publications covering thematic areas in Disaster Management

During the 10th year of DM CoP, we will create more space by adopting new communication technologies for greater role and participation of members. The DM CoP will address Resilience and Recovery issues and seeks members support to identify knowledge areas for dialoguing in the community.

In the month of April, two tele conferences were conducted. The first one was on National Disaster Management Plan for Animals/Livestock and the second was Mainstreaming DRR and CCA into Development Decision Making. On an average 12 people participated in each of the tele-conference. Thank members who participated in the 2 tele-conference held in April 2016.

The country is witnessing worst ever drought in a decade. Nearly 33% of population are facing drinking water crisis across 11 states. The water storage in the 91 reservoirs is at precarious level (22%) and may go down fast due to severe heat wave across the country. Relief and Mitigation measures under various national flagship programs can be taken up to address drought, livelihood and drinking water scarcity. The drought has impacted social, economic and environment seriously. Request members to share photographs, video clippings, statistics and newspaper information related to drought and associated issues.

Request members to participate in future online consultations, share topics for discussion, information and knowledge that can be disseminated. Thank members for their continued support and co-operation.





Disaster Management in the Country

Heatwave in India.

The Heatwave in the country is spread across, affecting the States that are already reeling under Drought conditions. It is observed that the temperature is being significantly higher than normal in most parts of the country. The MeT department's prediction of extreme, and extended, heat wave-like



conditions this summer seems to be coming true already. The maximum and minimum temperatures have been between five to six degree Celsius higher than normal in parts of Western Uttar Pradesh, Delhi, Eastern Rajasthan and some parts of Madhya Pradesh.

The minimum temperature is more than 5 degree normal in these places. The other states that are reeling under heatwave leading to deaths are Odisha, Andhra Pradesh and Telegana. Few areas of interior Jharkhand, Chhattisgarh and Southwest Uttar Pradesh

have also been observing heat wave conditions. MeT department has forecast markedly high temperature at few places over Punjab, at isolated places over Himachal Pradesh, Haryana and Delhi and East Madhya Pradesh

Forest Fire



Uttrakhand: The major forest fire season in the country varies from February to June. Reports have estimated that about 6.17% of Indian forests are subjected to severe fire damage annually. According to Ravi Chopra, an environmentalist and a former member of the National Ganga River Basin Authority (NGRBA), high temperatures with no atmospheric moisture were the major reason for this year's fires. High atmospheric temperatures and dryness offer favourable conditions for a fire to start, but in India several forest fires are human-made for new flush of grass and

agricultural practices like shifting cultivation.

What is the damage?

Though the exact damage is yet to be ascertained, environment minister Prakash Javadekar said around 1,900 hectares of forest area is affected. Forest officials fear wildlife could have faced problems too. Losses like carbon sequential capability, soil moisture and nutrient losses due to forest fire are very difficult to be ascertained but are of utmost importance for environmental conservation. It also contributes to global warming.

What is the government doing about the forest fire in Uttarakhand?

On Sunday (1 May 2016), the government said over 6,000 personnel from various state and central agencies are working to put out the raging forest fire in Uttarakhand. Javadekar said all top officers of the forest division are in Uttarakhand right now. "Our first priority is to douse the fire. We will then investigate if there is any foul play," Javadekar added.

The worst forest fires in the last 25 years


According to a report, Forest Fire Disaster Management, by the National Institute of Disaster Management under the Union Home Ministry, the four worst forest fires in the last 20-25 years are:

- 1. 1995- Around 375,000 hectares area affected in Uttarakhand
- 2. 1999 Around 80,000 hectares area in Ganga-Yamuna watershed
- 3. 2008 About 10,000 hectares area in Melghat, Maharashtra
- **4.** 2010 Around 19,000 hectare forest area in Himachal Pradesh

Droughts: India drought: '330 million people affected'

More than 330 million people are affected due to drought in India, as stated by Union Government to the Supreme Court of India. Authorities are of the view that the number are likely to rise further given that some states with water shortages have not yet submitted status reports. These are 31 million people in Karnataka, 36.9 million in Maharashtra, 16.7 million in Orissa, 23.5 million in Andhra Pradesh, 17.8 million in Telangana and 99 million in Uttar Pradesh.



The 255,923 villages in 254 Indian districts have been impacted by the drought. The highest number of villages hit by the water shortage is 42,829—was reported in the Madhya Pradesh state in Central India, followed by 29,077 villages in the eastern state of Orissa and 22,759 villages in Karnataka in South India. So far, 11 states have declared a state of drought, following two years of below-average monsoon rains

India is heavily dependent on monsoon rains, which have been poor for two years in a row. Water availability in India's 91 reservoirs is at its lowest in a decade, with stocks at a paltry 22% of their total

storage capacity, according to the Central Water Commission. The figure will likely dwindle further when the summer peaks next month.



Guidelines for Preparation of Action Plan- Prevention and Management of Heat Wave.

There has been an increasing trend of heat-wave in India over the past several years whereby several cities in India have been severely affected. Heat wave killed about 3000 people in 1998 and more than 2000 in 2002. Heat wave caused over 2000 deaths in 1998 in Odisha and more than 1200 deaths in 2002 in southern India. More than 2400 people died in the heat wave of 2015. Heat wave also caused death of cattle and wildlife besides affecting animals in various zoos in India.

Heat Wave Guidelines aims to facilitate the stakeholders in preparing a Heat Wave Management Plan by providing insight into the heat related illness and the necessary mitigative and response actions to be undertaken. It will also help in mobilization and coordination of various departments, individuals and communities to help and protect their neighbours, friends, relatives, and themselves against avoidable health problems during spells of very hot weather Please find <u>"Guidelines for Preparation of Action Plan – Prevention and Management of Heat-Wave"</u> published by The National Disaster Management Authority, Government of India.

Community-based Early Warning System



This brief describes a climate-integrated Community-based Early Warning System implemented by the Adaptation Learning Programme (ALP) in Dakoro, Niger. Integration of Community-based adaptation and disaster risk reduction (DRR) is important in a context of chronic vulnerability, recurring emergencies and increasingly unpredictable and extreme weather events associated with climate change. The brief provides a rationale for the early warning approach, including an overview of the associated benefits and challenges, as well as the key practical elements and lessons learned through implementation.
