

# **Strengthening Participatory** and Accountable Governance Project

As the situation in Iraq started deteriorating in June 2014, inclusive participation and social cohesion emerged as key to mitigate the impact of the crisis on the country's diverse ethnic population. Against this background, the United Nations Development Programme (UNDP) initiated Strengthening Participatory and Accountable Governance Project, as part of its Parliament, Civil Society and Human Rights Programme.

Aiming to strengthen the operational, outreach, legislative and oversight capabilities of Iraq's Council of Representatives (CoR) and selected Provincial Councils, the Project focuses on three thematic areas: Decentralization, national and community reconciliation, and inclusive participation in public policies. With its national geographic scope reaching the Kurdistan Region of Iraq (KR-I), the Project supports institutionalized capacity building to improve the effectiveness of CSOs, ethnic minorities and vulnerable groups, and participation in the legislative process.

#### **Target Beneficiaries**

• Council of Representatives: UNDP has been supporting the enhancement of the legislative and oversight capacity of Iraq's Council of Representatives through provision of expertise to the Presidency of Council, Secretariat, selected Parliamentary

#### **MATTERS OF FACT**

- **150** officials and representatives of CSOs received training in different areas
- **31** CSOs have been capacitated to advocate for protection of human rights and against corruption
- **21** CSOs established Human Rights Advisory Board to be the first institutionalized mechanism for engagement with the Council of Representatives

Committees (PCs), and core staff. A proposal for the establishment of a Budget Office has been developed and approved, in addition to capacity training for the Research Directorate to provide adequate support to members of the Parliament and Committees. The first strategic action plan and Standards of Procedure (SOP) for the Parliamentary CS Committee has been also drafted and adopted. Further to this, the project has facilitated the establishment of a network with Arab Regional Parliaments to promote the role of the CoR in advocating for decentralization.

- Civil Society Organizations: Working with CSOs, UNDP has helped to assess the Strategic Plan the NGO Directorate had developed in 2013. With the objective of extracting a concrete vision and work plan for the Capacity Development Unit, the assessment allowed for a clear understanding of internal capacities. A pool of master trainers will be established, combining the Directorate staff and NGO representatives. As a result, the Directorate will be able to expand its reach to the grassroots at no cost.
- Ethnic Minorities, Religious and Vulnerable Groups: Engagement between NGOs, CoR, and Provincial and District Councils has been fairly limited particularly on issues related to minorities, who have been gravely affected by the crisis. UNDP programming has been targeting ethnic minorities, religious groups, and vulnerable groups including women and youth, to enable effective participation in the legislative and democratic processes.

#### **National and Community Reconciliation**


As part of UNDP's commitment to support Iraq's transition towards reconciliation, a Strategic Framework for National and Community Reconciliation has been

developed. The document outlines the role of the Parliament and CSOs in social cohesion and peacebuilding. It champions national ownership through a leading role for elected representatives of the people of Iraq and support by civil society. Further assistance includes preparations for reconciliation initiatives and resulting developmental processes as a potential reconciliation dividend. With the understanding that reconciliation is unavoidable for its paramount importance to social cohesion and development prospects in Iraq, the local, provincial and national levels are envisioned to engage and work closely with civil society and various constituencies.

#### **Key Results**

Generous contributions from the Swedish International Development Agency (SIDA) and Denmark, as shown in the below figure, have enabled a broader impact of UNDP's Parliament, Civil Society and Human Rights Programme. The following are key results in 2015:


- Training of 150 officials and representatives of CSOs in areas such as protection of human rights and strategic planning;
- Establishment of CSOs Human Rights Advisory Board with the membership of 21 CSO representatives from various Governorates, including representative of minorities. Recognized by the Parliamentary Human Rights Committee, the Board is the first institutionalized mechanism for engagement between CSOs and the Council of Representatives;
- Capacitating 31 CSOs to advocate for protection of human rights and against corruption;
- Development of Strategic Framework for National and Community Reconciliation;
- Establishment of a network with Arab Regional Parliaments to advocate for decentralization; and
- Establishment of the first Budget Office within the Office of the Speaker of the Council of Representatives with technical advisory support from UNDP.
