

**Addendum No. 1
to the
Standard Administrative Arrangement
between
the Government of Sweden
and
the United Nations Development Programme**

WHEREAS, Participating United Nations Organizations that have signed a Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have developed a "Towards Unity in Action" Multi-Donor Trust Fund - Republic of Moldova (hereinafter referred to as the "Fund") starting on 2013 and ending on 31 December 2017, as may be amended from time to time, as part of their respective development cooperation with the Government of the Republic of Moldova, as more fully described in the Terms of Reference of the Multi-Donor Trust Fund (hereinafter referred to as the "TOR"), a copy of which is attached hereto as **ANNEX A**, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee") to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government of the Republic of Moldova for the implementation of the Fund;

Whereas in Section I, paragraph 1 of the Standard Administrative Arrangement signed between Government of Sweden (hereinafter referred to as the "Donor") and the Administrative Agent (hereinafter referred to collectively as the "Participants") on 25 June 2014, the Donor committed itself to make a contribution of SEK 19,500,000 (Nineteen Million Five Hundred Thousand Swedish Krona) "and such further amounts as it may decide (hereinafter referred to as the "Contribution" to support the Fund, earmarked to for Gender Equality Window within "Towards Unity in Action" Multi-Donor Trust Fund-Republic of Moldova MPTF;

WHEREAS the Donor has notified UNDP, the Administrative Agent of "Towards Unity in Action" Multi-Donor Trust Fund, of its intention to provide additional contribution to MPTF that would complement the Project: "Enhancing Women's Political Representation through improved capacity and enhanced support in Moldova", as more fully described in the Annual Work Plan and Budget 2016, attached in **ANNEX C**;

NOW THEREFORE the Donor and UNDP have reached the following understanding which shall constitute Addendum No.1 that shall compliment the Standard Administrative Arrangement:

Section I paragraph 1:

"1. The Donor shall place at the disposal of UNDP the additional amount of SEK 3,000,000 (Three Million Swedish Krona) in accordance with the schedule of payment:

Section I paragraph 2:

"2. The Donor will deposit the Contribution by wire transfer, in SEK, to the following account:

All other terms and conditions of the Standard Administrative Arrangement, except as amended herein, shall remain unchanged and shall continue in full force and effect.

This Addendum will enter into effect upon signature by both parties.
