Angeline Nkwenkam Nguedjeu is the Peace and Development Advisor in Congo Brazzaville since May 2017. She has experience working in Sudan, South Sudan and the Great Lakes with the UN Peace keeping Mission as Civil Affairs Officer, amongst others. Her expertise ranges from gender, capacity building, national cohesion and reconciliation processes as well as socio political context analysis supporting peaceful election processes and UNSCR 1325 National Action Plans (in Sudan, South Sudan, Kenya and Uganda). She contributed to food security related value chain developments in Ethiopia, Rwanda and Uganda. Starting her career as research assistant in Germany she worked for Bread for the World in Cameroon before joining the German Development Bank (KfW). Angeline holds a PhD in Social Sciences, and Masters in Political Sciences from the University of Heidelberg. Her previous research work focused on democratic processes in French speaking Africa

and women's empowerment and women's contribution to peacebuilding in post conflict Northern Uganda.

Julius Otim is the Women Peace and Security Specialist (WPS) for the UN Women East and Southern Africa Region (ESAR) leading the Peace and Security Portfolio. He has over 14 years' experience in WPS and was previously UN Women's WPS Advisor in Papua New Guinea coordinating gender-responsive peacebuilding in the Autonomous Region of Bougainville doubling as the Head of the Sub National Office. He has worked with UN Women South Sudan as the Gender & Security Specialist strengthening women's participation in peacebuilding and conflict resolution and as Gender Analyst worked with UNDP South Sudan leading the mainstreaming of Gender in Disarmament Demobilisation and Reintegration (DDR). He has also worked in Bangladesh as a VSO volunteer, as UNDP programme specialist in Afghanistan and Gender Adviser in Timor-Leste with UNIFEM.



He holds a Masters' Degree in Public Health and has over 14 years' experience in WPS.



Marie-Josée Kandanga works with UN Women Western and Central African Regional Office as policy adviser on Peace, Security and Humanitarian Action.
