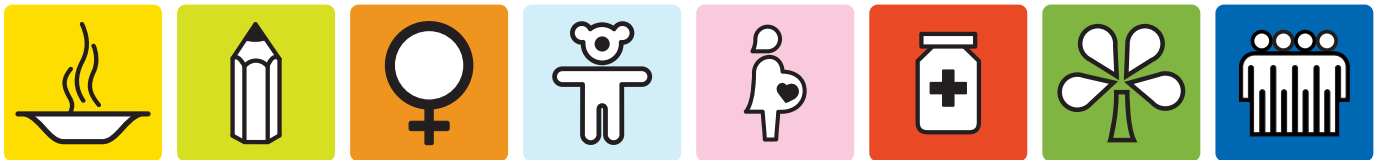

Khyber Pakhtunkhwa formerly called North-West Frontier Province, with an area of 74,521 km² (28,773 sq mi) borders the Federally Administered Tribal Areas to the west and south, Gilgit-Baltistan to the north-east, Azad Kashmir to the east, Punjab and the Islamabad Capital Territory to the south-east, and Afghanistan to the north-west. The provincial capital and largest city is Peshawar. Its snow-capped peaks and lush green valleys of unusual beauty have enormous potential for tourism.

BALUCHISTAN

Balochistan, is the largest of Pakistan's four administrative provinces in terms of area at 347,190 km² (134,050 sq mi), constituting approximately 44% of the country's total land mass, and the smallest in terms of population, being home to less than 5% of the country's population. It is bordered by Afghanistan to the north and north-west, Iran to the south-west, the Arabian Sea to the south, Punjab and Sindh to the east, and Khyber Pakhtunkhwa and Federally Administered Tribal Areas to the north-east. Quetta is the capital and largest city of Balochistan.
