CONTEXTUAL ANALYSIS

FEDERAL LEVEL

In Q3 the Mol and MoJ clarified matters that resulted in the suspension of Youth for Change activities in Q2, advising that Mol would be responsible for the rehabilitation of youth at risk within the communities who have not been brought to justice and that MoJ would be responsible for the rehabilitation of youth who had been convicted and gone through the judicial process. Consultations were held with all key stakeholders by the consultant engaged to support the development of a legal framework for the treatment of disengaging fighters in relation to the National Programme for the Treatment and Handling of Disengaging Combatants and Youth at Risks in Somalia. The consultancy report was finalised with the 26 recommendations to be considered by key stakeholders in Q4, noting the priority afforded to this area in the Somali Compact, under PSG 2: Security. The outcomes of the considerations of the recommendations will provide the framework for the recommencement of activities.

PUNTLAND

Political context remains unchanged since democratic process and local governance elections were postponed in Puntland. In Gardo, on 15th July there was violence against local governance elections while Project staff was there for project activities. This had limited the Project staff to have full access to project sites. However, this issue since has since been resolved. A mid-term joint review was conducted in September in Bosasso, bringing the Government, the UN agencies, the implementing partners and the beneficiaries together for a collaborative reflection on Y4C implementation. In Garowe, under the Ministry of Security and DDR (MOS-DDR), a building was allocated for the implementation of the Y4C and the first caseload of youth beneficiaries was registered. A strong working relationship with the Eyl municipality has been developed, establishing a mechanism for direct Y4C implementation by the Mayors office, District Council and Peace and Security Committees.

SOMALILAND

Somaliland remained a relatively peaceful environment for implementation in Q3. The Project remained engaged with the MOI as its key partner for the Y4C and the Community Security and Peace-building Unit (CSPBU) by providing technical expertise and capacity for the Unit to enable the oversight, implementation and monitoring of the Youth for Change joint initiative. The new Minister of Interior was fully briefed on the Project activities. Under the recently finalized Somaliland Special Arrangement the Project activities align to the Peace & Statebuilding goal (PSG) 4:Establishing Economic Foundations. There was successful social rehabilitation of the first Y4C intake & preparations for intake two (Q4). The project carried out Y4C activities in the conflict prone area of Las Anod without any complications. A mid-term joint review was conducted in September in Burao, bringing Government, UN agencies, partners & beneficiaries together for a collaborative reflection on Y4C implementation.

ACTIVITY HIGHLIGHTS

FEDERAL LEVEL

The Project did not implement any activities in Q3 at the Federal Level. Consultations between the Project, UNICEF and ILO were held with the legal consultant engaged to support the development of the legal framework for National Programme for the Treatment and Handling of Disengaging Combatants and Youth at Risks in Somalia. Currently the Project is not engaged with the National Programme, however depending on the outcome of the UN considerations of the recommendations from the consultant's report, and subject to the provision of additional funding resources, the project has the capacity, technical expertise and solid track record of successful interventions in Somaliland and Puntland, to be able undertake activities at the Federal Level.

PUNTLAND

To date, a total of 272 youth (F:32, M: 240) benefited from the Y4C social rehabilitation. 167 of these youth (F:2, M: 165) completed the social rehabilitation component and were handed over to ILO for the economic reintegration. Core trainings and preparations were carried out for the second intake of beneficiaries (e.g. instructors and mentors trainings, location setup in Eyl and Garowe). A Y4C mid-term joint review was conducted in Bossaso (by UNDP, ILO and UNICEF). A second intake of 50 beneficiaries (F:30, M:20) was registered in Gardo and 55 (F:0, M:55) in Garowe. ADR consultations were held in Garowe on 11th – 13th July 2013. ADR trainings were then provided for 27 practitioners (F:2, M:25) on human rights standards and the institutionalization of ADR.

SOMALILAND

A total of 281 youth (F:69, M: 212) benefited from the Y4C social rehabilitation. 231 youth (F:47, M: 184) graduated from the social rehabilitation component and were handed over to ILO for the economic reintegration. A mid-term joint review (UNDP, ILO and UNICEF) was conducted in Burao (10-13 September) September. The review identified key issues and recommended a way forward (see lessons learned). Active participation from INGOs in the CSPB Working group supported the development of new coordination tools (information sharing and service location mapping). Over Quarter 4, the group will look for opportunities to engage more conflict sensitive issues (e.g. Oil Exploration). Alternative Dispute resolution Consultations were held in Hargeisa 6 – 7 July 2013.

PARTNERSHIPS

The Y4C continues to function as a joint initiative between ILO, UNICEF and UNDP and is building momentum through a 'One UN' approach whereby the working relationships are strengthened and joint agency coordination and implementation of the work is more coherent. This improvement is due to a a willingness of all three agencies to understand each others roles; collaboratively approach the process; become involved in the programme design and implementation; and encourage respective implementing partners to take part in the coordination aspects. The Project continues to engage with the MoJ and MOI in SL and the MOS-DDR and the MOJ in PL. Building onto the work of Q2, the United Nations Institute for Disarmament Research (UNIDIR) continues to support a Phase II of evidence based programme design (EBD) training (assists in development of longer term Phase III of Youth for Change programme design, and capacity building of UNDP, UNICEF and ILO staff) and integration of EBD into the Y4C longer term programming. In Somaliland the Project and the Civilian Police project (CPP) team have worked towards an integrated approach to 'peace, security and development' between the project, CPP and JPLG and JPLG and the project have collaborated to support the Annual Work Planning development. Utilising funding from DFID, an Agreement was signed between the project and the OCVP in support to three years of research and capacity development.



PEACE AND CONFLICT

The Somaliland Special Arrangement provides for the strengthening of citizen-state relations and notes that grassroots development approaches, in line with Somaliland's traditional community-based governance structures, will be promoted. The Project's community based approach is aligned to this by facilitating dialogue and collaboration between civil society and government in order to drive programme implementation and direction. The Project continues to engage with the OCVP to support the enhancement of the DCSAs through improving and expanding data collection allowing for development of better baselines and increased access to information for comparative analysis. While testimonials provided by security providers during the Y4C joint review indicated that there has been a decrease in crime and insecurity at the local level, routine and rigorous collection of crime and security data is needed to provide quantifiable data to demonstrate progress towards peace.

GENDER

Gender mainstreaming is prioritized in the Somali Compact where emphasis is placed on women's role in stabilization. As indicated in the above results, the project focused on the inclusion of females as beneficiaries (achieving 14% of the 30% target) and support staff (achieving 18% of the 50% target). The challenge of female inclusion was explored in the joint review where stakeholders expressed that male beneficiaries require male support staff in order to be culturally sensitive. Although research shows that male youth (ages 14 to 26) are more likely to be engaged in criminal activity and violence, females also are personally affected and are both exponents and enablers of criminal activity and violence. For example, one female focus group discussion member admitted to assisting a criminal gang by keeping stolen goods at her house before she was admitted into the Y4C. Further analysis will be undertaken on how the Y4C can communicate its objectives to include more females.

UPCOMING QUARTER

An internal review of the project will continue in order to streamline strategies and activities for 2014. A tracer study by the NRC will progress to evaluate beneficiaries of the Youth at-Risk pilot project. A thorough review of the DCSAs will be conducted. The second intake of Y4C beneficiaries (total target of 550) will complete the social rehabilitation before moving to the next phase implemented by ILO for economic reintegration. In Puntland, the ADR programme will commence and two community dispute resolution houses will be established in Bosasso and Garowe. In South Central, in conjunction with JPLG, the Project will provide technical support for the stabilization unit under the prime minister's office to formalize the position of the District Peace Committees under the District Council (under JPLG). Active resource mobilization will be carried for supporting anti-piracy and Youth initiative activities.



REFLECTIONS / LESSONS

The Project is undergoing a reflection and evaluation period to help realign objectives and programming. Board consultations on project progress and direction were held with key government stakeholders and project staff in Somaliland (28 September) and in Puntland (6 October). The reviews highlighted an overall need for the Project to clarify the goals to its stakeholders and clearly define how the work we do is meaningful to the reduction of violence. There is still need for capacity building of counterparts and creation of space for them to take part in project design, planning and implementation processes. Coordination also must be better defined according to the National planning arrangements and sector forums as stipulated in the Somali Compact.

Research for the purpose of monitoring is essential to understand whether the Project is meeting the objective of reducing crime and violence. At the moment, only the tracer study (data currently being collected) and the DCSAs exist to measure the impact of the interventions (against the 2009 Safety and Security Baseline Reports). The relationship between the OCVP and its support to the government counterparts needs to be more clearly defined and the analysis of the data collected will inform the programming under the project.

The Y4C joint mid-term review was held in Somaliland (10-13 September) and in Puntland (15-17 September). The best practices and lessons learned include the following. First, social rehabilitation is working, whereby the youth themselves appear to value the programme and see it as an avenue to broadened future prospects. This is likely because the youth are exposed to Y@R beneficiaries who now are employed and therefore set a positive precedence of expectations of the programme. Also parents, mentors and facilitators alike agreed that the programme does in fact instill positive behavioural and attitudinal change within the youth. Second, the 'One UN' approach has consolidated efforts of project implementation under the Y4C framework. Third, overall, many of the teething problems experienced in the pilot phase were ironed out and the systems are working more fluidly. The changed focus to one component at a time has proven to be extremely beneficial to all parties involved whereby the youth have time to transition; the facilitators and centre managers are not overwhelmed and have more time to focus on delivering quality programming to the beneficiaries, rather than merely cope with over-sized classes of unruly youth. Challenges still exist with remote management and ensuring full and active coordination at the district level. Also challenging is the lack of access to quantitative data (i.e. regular and routine record keeping of crime and insecurity incidents made available for comparative analysis).

The Project is keen to commence activities in South Central, however the legal and human rights issues related to the National Programme must first be considered.
