CONTEXTUAL ANALYSIS

FEDERAL LEVEL

At the Federal Level (FL), the security situation remains complex. After the recent assassination of Al-Shabaab co-founder, Ahmed Godane, in a US airstrike, fears of retaliation have increased already high tensions throughout the South Central region. The increasingly high security alerts limit the movement of UN staff and impact their ability to meet and coordinate with partners, including in Mogadishu. Though political tensions erupted in the Bay region related to the ongoing state formation, there was no disruption to the project activities during the reporting period. The Youth for Change (Y4C) and the Community Security index (CSI) components of the Community Security Project continue to be implemented in the Benadir and Bay regions. Collaboration with the Ministry of Youth and Sports is increasing through the established M&E unit to support the Ministry's supervision and ownership of Y4C. Collaboration with the Ministry of Interior and Federalism on stabilization has progressed.

PUNTLAND

Puntland (PL) cut ties with the Federal Government on 31 July and withdrew its federal members of parliament from Mogadishu. It hosted a consultation for MPs after an agreement signed in Mogadishu stated that the Mudug region, which is partially within Puntland territory, would be attached to Central Somalia. Diplomatic talks are in progress.

Terrorist threats to the UN Common Compound still remain, resulting in decreased UN operations in the Region.

The Project has nevertheless successfully conducted activities in Bossaso, Gardo, Garowe, Burtinle, Eyl and Dhahar in the framework of its Y4C, CSI and Alternative Dispute Resolution (ADR) initiatives. Trainings were held in Garowe for new ADR practitioners from across PL. They covered the ADR concept which links the traditional justice system to the secular system to build complementarity and standardize practices.

SOMALILAND

The general Somaliland (SL) context has remained stable, although there were military clashes between the Khaatumo fighters and SL forces in the Sool, Sanaag and Cayn regions, in the east of the territory. The dispute has development and humanitarian implications in the region. However, this did not impact project activities being carried out in Burao, Odweyne and Hargeisa under the Youth for Change (Y4C), Community Security Index (CSI) and Youth Re-entry Parole Pilot Project. The social rehabilitation of 70 youth ex-offenders has started in Hargeisa under the Parole Pilot Project.

ACTIVITY HIGHLIGHTS

FEDERAL LEVEL

The Y4C M&E Unit was established under the Ministry of Youth and Sports (MOYS).

A Y4C Mentorship Training for 24 Mentors (F:6, M:15) was conducted 8-9 October, and a Y4C Facilitators Training for 16 Facilitators (F: 0; M: 16) was conducted 10-11 October 2014. The Community Security Project national officer carried out a monitoring mission to Baidoa. AY4C coordination meeting was held at the MOYS and attended by all Y4C implementing partners.

A District Peace and Stability Committees Training of Trainers was conducted for 14 participants (F: 3; M: 11) with MOIF. A second dissemination workshop was held in Mogadishu for the Baidoa District Conflict and Security Assessment report (OCVP).

The first wave data collection under the CSI began under the District Councils of Davnile and Hamar Jai PUNTLAND

An ADR training was conducted in Garowe (4-8 August) for 40 selected Elders and Sheikhs from four districts (Bossaso, Dhahar, Burtinle and Eyl). The training was facilitated by an international legal expert. Two days of Judiciary Trainings were conducted (11-13 August) to improve the interaction and understanding between the formal justice system and informal system (Sheikhs and Elders). Participants were judges, prosecutors, police officers and lawyers.

The induction and the orientation session of the new staff for case management and record keeping was conducted in Garowe ADR Center. Y4C Social Rehabilitation continued for 160 youth (F: 96; M: 64) in Gardo (56 F: 24 M) and Bossaso (40 F: 40 M). The first wave of CSI data collection was conducted in Gardo and Garowe.

SOMALILAND

Parole Draft regulations and training manual were completed (each pending endorsement of the Prison Act). Parole trainings were held for senior officials (24 September 2014) and included representatives from the Attorney General's Office, Regional Chair from the Parole Committee, Corrections Corps, Minister of Justice and Director General, Mayor & District Councils. The training for operational staff (27-29 September) included all support roles. 70 youth (F:20, M:50) were enrolled into social rehabilitation. CSI training was conducted from 3-6 August. A total of 17 individuals (4 female) from the research units across the three regions participated. The Y4C social rehabilitation continued for 80 youth (F:27, M:53) in Burao.

PARTNERSHIPS

The CSI (under GON) initiative, Forcier Consulting Firm supported the guantitative training and data collection and the OCVP supported the qualitative aspects. The CSI is implemented in partnership with the District Councils of Burao and Odweyne (SL); and Gardo and Garowe (PL). At the FL, the CSI is implemented under a LNGO, Centre for Peace and Democracy (CPD). The Y4C is implemented with UNICEF and ILO. UNDP Y4C partners include the District Council of Burao and LNGOs in PL: the Youth Peer Network (Bossaso) and PL Development Organisation (Gardo). At the FL, the Project is partnered with LNGOs: the Somali Youth Development Network (Wadajir district), Aamin Voluntary and Relief Organisation (Karaan district), CPD (Hamar Jajab and Dhakinley districts), Kanava Youth Development Organization (Baidoa).

At the FL, the Project signed an agreement with the MOYS to support the coordination, monitoring and evaluation component of the Y4C.

The project has also engaged with the MOIF to support the reconciliation component of the Peacebuilding Fund Project. A District Peace and Stability Committees Training of Trainers was conducted in September for 14 participants from SOYDEN, CPD and MOIF.

Partnership is strengthened with the UNDP Access to Justice Project (Youth re-entry and ADR initiatives).

In SL, the project partners with the Ministry of Justice (MOJ), providing support to the YRE. The Project remains engaged with the OCVP (all regions).



PEACE AND CONFLICT

At the FL, the recent assassination of Ahmed Godane of Al-Shabaab caused increased tensions and suspected retaliation. The conflict at the FL continues to pose a challenge for implementation of project activities; however the project was able to remain on target in implemention in all three regions.

The disputed Sool and Sanaag territories remain volatile along the PL and SL borders. Increased Al-Shabaab presence in PL has resulted in continued restriction of movements.

On 21 September 2014, PL marked International Day of Peace in Garowe with an event where the Puntland President Abdiweli Mohamed Ali demonstrated his support for lasting peace across Somalia.

The Project developed the CBRTH agreement with SOYDEN which will engage 4 target areas (1 district in Baidoa, 1 district in Beledweyne and 2 wards Kismayo). ADR and Judicial trainings were conducted in PL for both traditional and formal justice practitioners.

GENDER

The Y4C includes 46% female intake (F:227, M:273). Notably the caseloads at the FL included 40% females (F:105, M: 155); in Burao (SL) it included 34% females (F:27, M:53); and in PL, the numbers in Bossaso were 51% females (F:41, M:39) and in Gardo 67% females (F:54, M: 26).

A female intern was attached to the Y4C M&E unit under the MOYS as per explicit requirement under LoA. The Y4C Gender Manual is currently being revised by an international education specialist. The YRE includes 28% females (F:20, M:50). A female centre manager was hired to lead the social rehabilitation component of the YRE and a female ITC specialist was hired to lead the parole database development.

UPCOMING QUARTER

Project Board meetings are scheduled to take place Mid-October-November.

The Y4C social rehabilitation activities will conclude in Q4 for all project locations with subsequent handover to ILO for the second component of economic reintegration.

CSI Wave 2 of data collection will be carried out. Wave 1 reports will be published.

CBRTH will commence in Baidoa, Kismayo and Baledweyne with SOYDEN.

PBF-funded Project with MOIF will initiate, supporting FGS in stabilization efforts in recovered areas by establishing interim administrations that will lead an inclusive dialogue and promote reconciliation.

OCVP will undertake new conflict and security assessments under new agreement.

Following the recruitment of personnel, the MOJ-RAR (PL) will support the roll-out of the ADR component in Dhahar, Burtinle and Eyl.

The YRE social rehabilitation processes will continue. Follow-up and future strategic planning for the Prison act and extension of the pilot project will be carried out.



REFLECTIONS / LESSONS

CBRTH: At FL, the project continues to deliver its activities but the complex environment creates added challenges at the design stage as many factors – such as local capacity and security – must be thoroughly considered before activities commence. Due to this, the new project components, i.e. the Community Based Reconciliation and Trauma Healing, intended to be implemented over 2014, have encountered many delays. The strategy for engaging at the community level is being worked out with the support of a LNGO with in depth experience in community reconciliation. These activities are now expected to commence in Q4.

Y4C: After a year of project activities being on hold in Benadir and Bay regions, newly formed ministries under the Federal Government brought new opportunity for engagement. However, protocol, roles and responsibilities had to be well defined ahead of engagement, needing time, to ensure success. In the experience of Y4C in particular, partnerships were shifted from the traditional LNGO engagement to a process led and monitored by new government counterparts, with responsibilities, entitlements and control necessitating clarification.

YRE: The Pilot Project consists of two main components: (a) developing the legal and normative frameworks for a Parole system; (b) a customised Social Rehabilitation process for the youth as they exit prison life and re-enter their home communities. Lessons learned so far include:

-Legal frameworks must be in place before roll out / implementation. The desire to hold the first set of Parole hearings was initially stalled due to delayed endorsement of the Prison Act. This has left the work on the Parole regulations and training Manual as draft forms and confused training participants.

-Systems must be accompanied by a communication campaign. For most Somalis, the concept of Parole is new. Due to the oral culture and joint decision making processes, a Parole system where prisoners are released prior to completion of their sentence without community buy-in into the processes first creates a risk within the community and to the Parolee. -Longer term commitments in funding will strengthen the planning process. For instance, Parole trials cannot be completed unless there is funding to sustain the process for one complete Parole cycle. This has led to a halt in such planning until longer term commitment is secured.

CSI: Gaps in qualitative data analysis were identified upon initiation. The use of innovative solutions such as the recruitment of online volunteer experts helped fill the gaps without extra cost or major delay to implementation.

ADR: Some confusion and apprehension appeared among legal practitioners based on the belief the project would create a separate and parallel justice system. This was dissipated by the international expert clearly explaining its aim as reinforcing links and complementarity between informal and formal justice mechanisms under the oversight of the formal justice system.
