POLITICAL UPDATES

President Announces Date for Early Parliamentary Elections

The President of the Republic has announced to conduct the elections for the National Parliament on 12th May 2018. Election date was announced after the President on 26th January issued a decree to dissolve the National Parliament after no consensus was reached between the political parties to agree on the new Government Program and the State Budget.

The electoral law on the elections to the National Parliament will be for 65 members chamber in one single national constituency, through a closed and blocked-list proportional representation system. The elections will be conducted in all 12 municipalities, Authority for Special Administrative Region of Oe-Cusse (RAEOA) and out of country in Australia, Republic of Korea, Portugal and the UK. Technical Secretariat for Electoral Administration (STAE) will prepare an electoral calendar which will be the basis for the conduct of each activity until the results are declared by the Supreme Court of Justice.

Minister of State Administration Inaugurates Preparation Event for the 2018 Parliamentary Elections



Minister of State Administration Dr. Valentim Ximenes inaugurates joint-coordination meeting for the preparation of 2018 parliamentary elections on 22nd February in Dili. Technical Secretariat for Electoral Administration (STAE) facilitated the meeting with security offices, President of Municipalities, Municipal Level Voter Education Directors, Brigadas (Polling officers) of Dili Municipality and National Electoral Commission (CNE).















The meeting was the first event of STAE after the release of operational calendar for elections. There were 140 participants out of which 60 were women who were informed on the importance of this election to the previous elections and subsequently on electoral legal framework, operational calendar, voter registration, planning for logistic arrangements and voting centres. UNDP Electoral Project supported this event with the financial contribution from Government of Japan and Korea.



CNE Convenes Conference on Democracy- Achievements and Challenges

A conference on "Democracy in Timor-Leste: Achievements and Challenges" was organized by National Commission for Elections (CNE) on 26th January in Dili with the support from UNDP Electoral Project-LEARN. The conference is organized as part of project's assistance to the Election Management Body (EMB) for institutional strengthening.

The President of Republic who could not be present in the conference, through his message commended CNE on continuously developing initiatives to promote enlightenment and training on the relationship between democratic rights, the duties of citizens and the functioning of the electoral system. He further stated that this conference is held at the right time when there is political uncertainty in the country and the functioning of democracy and participation of citizens are the ultimate goal of transforming dignity into a tool for social development.

The Conference convened several sessions on-Rights of the political parties and their obligations; Legal



perspective to ensure Timor-Leste's governance; Concept of Peace national unity in ensuring the stability of governance in Timor-Leste.

The President of CNE, Dr. Alcino Baris reiterated that this initiative was necessary to inspire the efforts of CNE in consolidation of governance and democracy for securing the rights and principles as proclaimed in the Constitution of the Republic.





RDTL and UNDP signs agreement to procure indelible ink for parliamentary elections

Minister of State Administration Dr. Valentim Ximenes and United Nations Development Programme (UNDP) Country Director, Mr. Claudio Providas signed an agreement today for the procurement of indelible ink for the early parliamentary elections going to be held on 12th May 2018. The date for the early parliamentary elections was recently announced by the President of the Republic through a presidential decree. UNDP through this agreement will procure 4000 bottles of indelible ink with 25% silver nitrate and hand over to the Technical Secretariat of Electoral Administration (STAE) responsible for management and administration of elections in Timor-Leste. The indelible ink is a sensitive material used in elections that is an effective security feature to prevent electoral fraud such as multiple voting. It is not possible for a voter to remove it quickly. In Timor-Leste, each voter after casting their ballot, applies the ink on its index finger while exiting the polling station.

The agreement between the government and UNDP was reached because of the experience of UNDP procuring indelible ink since 1999 and recently 9000

bottles for the national elections in 2017. It is because of the trust in UNDP process, the government has decided to request UNDP for the procurement of ink. Minister of State Administration is highly convinced that the process would be transparent and quality of the ink would be as according to the pre-requisite standard. Mr. Providas has thanked the government for entrusting UNDP in such an important period and assures to fulfill the expectation of the government.



'EMBs convenes meeting with Diplomatic Corps on Early Elections'

After the announcement of early Parliamentary Elections by the President of Republic, the Election Management Bodies of Timor-Leste- CNE and STAE on 5th February convened a meeting with the diplomatic community in the country. The meeting was held to provide information and updates on the progress made towards the preparation for early parliamentary elections and also seek support when necessary during the implementation phase.



The EMBs during the meeting highly appreciated UNDP, Government of Japan and Korea providing extensive technical support in the previous Presidential and Parliamentary Elections in 2017. Most of the ambassadors attending the meeting pledged their support for the elections to the EMBs. The meeting was co-chaired by Resident Coordinator a.i. of UN, President of CNE, Vice-Minister of State Administration, Resident Representative of UNDP and Director General of STAE.
