SPOTLIGHT INITIATIVE

To address the challenges of violence against women and girls (VAWG), the European Union (EU) and the United Nations have embarked on a new multi-year programme - the EU-UN Spotlight Initiative. The Spotlight Initiative aims to support transformative change on the ground to end violence against women and girls and harmful practices, in numerous countries globally. The Spotlight Initiative in Timor-Leste is being implemented through five UN agencies (UN Women, UNFPA, UNDP, UNICEF, and ILO) with a focus on addressing intimate partner violence and domestic violence. The UNDP's actions focus on strengthening evidence-based legislation to address violence against women and girls, capacity strengthening of institutions and municipal authorities to plan, fund, and deliver evidence-based programmes that prevent and respond to gender-based violence (GBV), engaging with partners on GBV prevention initiatives via media, and ensuring that survivors of GBV have access to quality essential and legal services.

Development Challenges



59% of Timorese women (15-49 years) reported having experienced physical and/or sexual violence by an intimate partner in their lifetime



75% of women survivors of physical or sexual violence never told anyone nor sought help



38% of married women experienced physical or sexual violence by their husbands



More than 3 out of 4 women and men believe that a man is justified in physically beating his wife.

What we have achieved

- 36 Vulnerable Persons' Unit Officers** (24 females; 12 males) have enhanced their **knowledge on investigating cases of sexual assault & child abuse** after attending training delivered in collaboration with TLPDP and PNTL Training Centre.
- 116 Community Police Officers** (13 females; 103 males) across the country have **increased awareness** on how to handle sensitive cases of gender-based violence and intimate partner violence occurring in the community.
- More than 420 survivors** of gender-based violence in safehouses received food and non-food items following the April 2021 floods.
- A comprehensive assessment** of laws, policies, and practices affecting gender equality and gender justice in Timor-Leste has been **completed**, accompanied by 3 knowledge products
- A total of 156 people**, including youth and women, (70 females, 86 males) **participated in awareness-raising campaigns** on the formal justice system and gender-based violence, mostly at the village level and in rural areas of Bobonaro, Ermera, and Viqueque.
