## 1. BACKGROUND

According to the National Survey on Persons with Disabilities conducted in 2016, 7.06 % of the population aged 2 and over were disabled. The number of PWDs was around 6.2 million people. This number in rural areas is 1.5 times higher than in urban areas.<sup>1</sup> This number has increased due to the ageing population, traffic accidents, and pollution. This survey also indicated that "households with PWDs are twice as likely to be poor as non-disabled households".<sup>2</sup> Of PWDs aged 2 or older, 17.8% live in multidimensional poor households.<sup>3</sup> PWDs still face many challenges in accessibility and participation in society. The impact of disability is not only felt for PWDs, but also for their family members who often share the costs and care for expenses such as medical treatment, or special education among other things.

In December 2014 Viet Nam ratified the Convention on the Rights of Persons with Disabilities (CRPD). Persons with disabilities and their representative organizations played an integral role in the formulation and negotiation of the Convention under the slogan "Nothing about us without us!". The Convention recognizes that this role must continue, requiring States parties to "closely consult with" and "actively involve" persons with disabilities in decision-making processes related to them.

UNDP Viet Nam is working to strengthen the protection and promotion of the rights of persons with disabilities in Viet Nam, with the goal of ensuring alignment with the CRPD. The current portfolio focuses on a number of key areas to achieve this objective, and responding to other emerging issues as they arise:

- Legal reform to strengthen alignment with the CRPD, including revision of the Law on Persons with Disabilities
- Ratification and implementation of key international standards, including the Marrakesh Treaty
- Research and data collection on experiences of and impacts on PWDs in Viet Nam

- Ensuring a disability inclusive recovery in the context of COVID-19
- Support to UXO survivors
- Innovation and entrepreneurship to strengthen accessibility for PWDs

In this context, UNDP is recruiting a National Intern to support the work of the Disability Inclusion Portfolio in Viet Nam. UNDP is looking for a highly motivated young Vietnamese who is passionate about the rights of persons with disability and will help UNDP communicate our work on this topic to a wider audience.

# 2. OBJECTIVE

The National Intern is expected to support the successful delivery of activities under the Disability Inclusion Portfolio of work, by contributing to the organization and logistics of events, drafting and review of documents, preparing basic research, the production and dissemination of communication and engaging with partners and persons with disabilities, among other tasks.

## 3. SCOPE OF WORK

The National Intern will be involved in activities under the Disability Inclusion Portfolio working directly with the Disability Rights Officer and other relevant Programme and Operational staff.

Specifically, they are expected to undertake the following activities:

- Proof reading and translation of documents
- Basic research and reporting writing
- Support to event organization
- Support social media and communication content
- Support development of training programmes for health staff and PWDs on digital employment
- Support to mainstreaming of disability in UNDP Country Office
- Support to drafting of funding and project proposals

### 6. DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

The assignment will be conducted full-time from September 2020 to March 2021. The National Intern will be based in the Green One UN House - Hanoi, Viet Nam, with possible field travels to other locations in Viet Nam. Such travel cost, if required, are reimbursed by UNDP on the same basis as costs reimbursed to staff members, including payment of daily subsistence allowance, as applicable.

- Be enrolled in a postgraduate professional traineeship program and undertake the internship as part of this program.

## 9. FINANCIAL SUPPORT

UNDP will provide a stipend in the amount of <u>USD 287 (two hundred and eighty seven US Dollars)</u> <u>monthly</u> in accordance with the provisions of the UNDP Internship policy.

Payments will be paid monthly based on a timesheet and monthly report submitted and accepted by UNDP Disability Rights Officer. The payment will be made using the official rate of exchange applied by the United Nations on the day the UNDP instructs its bank to effect the payment(s)
